


I, Bhaktawar Singh, aged about 77 years, S/o Shri ^{Dheer} ~~Sigla~~ R/o Shastri Nagar, Saharanpur district, Uttar Pradesh, 247001, do hereby solemnly affirm and state as under-

1. That I am the President of Respondent No. 3 Jila Saharanpur Bricks & Tiles Nirmata Samiti Association, and I am duly authorised to represent the Respondent No. 3 in the in the present proceedings, and am well conversant with the facts and circumstances of the case.
2. This is affidavit is being filed by Respondent No.3 in terms of the order dated 10.09.2025 passed by this Hon'ble Tribunal.
3. Respondent No.3 is the Association of brick kilns operators in District Saharanpur, U.P., and presently there are 269 numbers of the brick kilns which are members of the Association. A list of members of the Respondent No.3 Association is Annexure R-1.





4. After going through the contents of the present OA, Respondent No.3 Association notes that District Saharanpur, which adjoins the NCR, is identically placed to Districts Mathura and Aligarh in UP, and District Hisar in Haryana. In respect of Mathura, Aligarh and Hisar, this Hon'ble Tribunal has passed orders to the effect that notwithstanding these Districts are outside the NCR, the directions given by the Hon'ble Supreme Court in Civil Appeal (Civil) D. No. 18213 of 2021 in respect of operation of brick kilns in NCR, will apply to these districts as well. Part of the directions issued by the Hon'ble Supreme Court are that the operation of the brick kilns will be restricted between March and June of each year, i.e. less severe air quality months. Specifically, such directions were applied in O.A. No. 93 of 2021 (*Mukesh Kumar Agarwal v. CPCB & Ors.*) by order dated 09.05.2022 for Mathura district, in O.A. No. 253 of 2021 (*Jhaman Lal Gautam v. Union of India & Ors.*) by order dated 08.07.2022 for Aligarh district, and in O.A. No. 342 of 2023 (*Hisar Zig Zag Bhatta Association v. Union of India & Ors.*) by order dated 22.05.2023 for Hisar district.
5. Since, District Saharanpur is identically placed as Mathura, Aligarh, and Hisar districts, the members of the Respondent Association, being law abiding citizens who are operating their brick kilns in accordance with law, have no objection to comply with similar directions for District Saharanpur, if so ordered by this Hon'ble Tribunal, and consequently restrict their functioning between March and June of each year.

That it is, however, respectfully submitted that there are about 25-30 brick kiln units presently operating illegally in District Saharanpur without obtaining necessary consent to operate or complying with applicable norms. Such brick kilns are not the members of the Respondent No.3 Association. It is thus prayed that while members of the Respondent No.3 Association are willing to comply with orders passed by this Hon'ble Court, at the same time the Uttar Pradesh Pollution Control Board and other concerned authorities may also be directed to strictly enforce the law and take appropriate action against such illegal units.






