
MOST RESPECTFULLY SHOWETH.

महोदय,

उपरोक्त विषय के संबंध में उपमंडल पश्चिम रोड-2-1 के पत्र के द्वारा बताया गया है कि उक्त पी.डब्ल्यू.डी रोहतक रोड पर भूमिगत पैदल पथमार्ग रामपुरा नजदीक पट्रोल पम्प से रामपुरा रेड लाईट तक कुछ अनाधिकृत लोगों एवं मुर्तिकारों द्वारा सरकारी भूमि पर काफी मात्रा में अनाधिकृत झुग्गीयाँ बनायी हुई है। जिसके कारण उक्त क्षेत्र में नालों की सफाई, फुटपाथ, सर्विसरोड, सड़क एवं भूमिगत पैदल पथ का रखरखाव एवं अन्य निर्माण/सौन्दर्यकरण/पुनर्रचना आदि कार्य करने में काफी बाधा आती है।

अतः इस संदर्भ में आपसे अनुरोध किया जाता है कि उक्त अनाधिकृत अतिक्रमण कब्जा, झुग्गीयाँ इत्यादि को तुरन्त प्रभाव से हटवाने हेतु Anti Encroachment Drive चलाने के लिए District STF के अर्तगत आवश्यक कार्यावाही करे।
