**FACTUAL STATUS / REPORT ON BEHALF OF CENTRAL GROUND WATER
AUTHORITY IN COMPLIANCE TO THE HON'BLE NGT ORDER DATED
24.09.2021 IN O.A. NO. 438/2018 (ARTI VS. CGWA & ORS.)**

Most Respectfully Showeth:

1. That in the matter of Arti vs. Central Ground Water Authority and Ors. (O.A. No. 438/2018), the Hon'ble Tribunal, Principal Bench vide Order dated 24.09.2021 directed the answering Respondent to place the complete information on record about the status of compliances by the concerned parties.

CORRESPONDENCE BY CGWA WITH THE CONCERNED AUTHORITIES

2. That vide letter dated 11.10.2021 the District Magistrate, Ghaziabad was reminded about the requests from the answering respondent regarding necessary action to be taken against the illegal bore-wells and the incomplete compliance report received on 31.12.2018 and was again requested to confirm the current status on ground water use by rest of the Respondent units and the action taken in this regard. (Copy of letter dated 11.10.2021 to the District Magistrate, Ghaziabad is enclosed herewith as **Annexure A**).
3. That a letter dated 11.10.2021 was also sent to Member Secretary, Uttar Pradesh Pollution Control Board (UPPCB) in compliance with the aforesaid order, requesting to confirm whether any remedial measures were taken with respect to illegal ground water abstraction against rest of the respondent units. It was further requested to nominate an officer for the Joint Inspection team constituted by the answering Respondent. (Copy of letter dated 11.10.2021 to the Member Secretary, UPPCB is enclosed herewith as **Annexure B**).
4. That vide letter dated 11.10.2021, the Director, Uttar Pradesh Ground Water Department (UPGWD), Government of Uttar Pradesh was requested to provide information whether any Respondent unit had applied for or was granted No Objection Certificate for ground water withdrawal from the said Department. It was further requested to nominate an officer for the Joint Inspection team constituted by the answering Respondent. (Copy of letter dated 11.10.2021 to the Director, UPGWD is enclosed herewith as **Annexure C**).

5. That taking into consideration the Order dated 31.07.2018 of the Hon'ble Tribunal in the instant matter, vide letter dated 11.10.2021, the Chief Engineer, Uttar Pradesh Jal Nigam was also requested to nominate an officer for the Joint Inspection team constituted by the answering Respondent. (Copy of letter dated 11.10.2021 to the Chief Engineer, U.P. Jal Nigam is enclosed herewith as **Annexure D**).

CONSTITUTION OF JOINT INSPECTION COMMITTEE

6. That subsequently, a Joint Inspection Committee was constituted by Regional Director, Central Ground Water Board, Northern Region, Lucknow vide letter no. 4(237)NGT/CGWB/NR/S&I/202Q1/893 dated 28.10.2021 with the objective to ascertain the factual status of ground water abstraction by the respondent units and inspect the premises and an Office Order dated 03.11.2021 was issued regarding inspections by the Joint Committee comprising of following officials:

7. That the Joint Inspection Committee visited the premises of 121 Respondent units¹ to carry out inspections of ground water withdrawal by these hotels in Ghaziabad from 11.11.2021 to 16.11.2021. Sh. Mohan Prakash Paswan, Executive Engineer from Minor Irrigation Department, Ghaziabad could not come for inspections due to illness.

OBSERVATIONS OF THE COMMITTEE

8. That a Report has been prepared by the Joint Inspection Committee incorporating complete information about the current status about the use of tubewells for extraction



10. That it was observed by the Committee that as on date the respondent units which are using tubewell(s) irrespective of whether water is being supplied by the Nagar Nigam, do not have permission of ground water withdrawal from the Authorized Officer / concerned department / answering respondent. Only two units have applied for NOC in Uttar Pradesh Ground Water Department.
11. That it is respectfully submitted that the answering Respondent had notified various areas for the purpose of regulation of ground water development, wherein exploitation of ground water for any use other than drinking & domestic purposes was not being permitted.
12. That the Municipal Corporation of Ghaziabad was notified on 04.04.1998 and according to the then prevailing guidelines of the Authority, the permission to abstract ground water for the purpose of drinking water in the Notified Areas was granted by the Authorised Officer in consultation with the advisory committee constituted for this purpose. The District Administrative Heads (Deputy Commissioner/District Magistrate/District Collector) in case of Administrative Block or Taluka, or the Head of the Municipality (in case of Municipal Area) of the notified areas in the country have been appointed as 'Authorized Officers' by Central Ground Water Authority under Section 4 of the Environmental (Protection) Act, 1986.
13. That the answering respondent had stopped processing applications for No Objection Certificate for ground water extraction in OCS areas (non-notified areas) in compliance to the Hon'ble NGT order dated 03.01.2019 in O.A. No. 176/2015, wherein the Hon'ble NGT had directed that Central Ground Water Authority Guidelines/Notification dated 12.12.2018 may not be given effect to and an appropriate mechanism/regulatory regime may be introduced consistent with the needs of the environment.

14. That it is respectfully submitted that Uttar Pradesh State Ground Water Management & Regulatory Authority has been constituted by the State Government of Uttar Pradesh for the regulation and management of ground water resources and issuing of NOCs for ground water abstraction in the State of U.P., and the said Department is completely functional since October, 2020. Issuing/Renewal of NOC to the project proponents in the State of Uttar Pradesh is no longer within the purview of Central Ground Water Authority. Thus, all the project proponents / ground water users in the state of Uttar Pradesh are now required to comply with the provisions of Uttar Pradesh Ground Water (Management & Regulation) Act, 2019.
15. That it is respectfully submitted that the said Report by Joint Inspection Committee regarding the present status of ground water withdrawal has been shared with the District Magistrate, Ghaziabad and Uttar Pradesh Ground Water Department with a direction under Section 5 of Environment (Protection) Act, 1986 to take further necessary action and ensure compliance of NGT Orders in this regard.
16. That it is most humbly prayed that the Hon'ble Tribunal may kindly be pleased to take the factual status / report on record and the Hon'ble Tribunal may kindly be pleased to dispose of the Original Application with appropriate orders in the light of the factual report and submissions made herein above.

The applicant before filing an application in Hon'ble NGT, New Delhi has submitted a complaint dated 2.7.2018 to CGWA without any details (copy enclosed). The CGWA has provided a copy of complaint format and advised the complainant to submit complaints in the format with full details, considered necessary/relevant for taking action. Instead of providing details, the applicant approached Hon'ble NGT against respondents' No. 5 to 126(copy enclosed) of the OA. Since there can be action at your end against respondents who have no valid NOC from CGWA for ground water extraction, the matter was referred to Regional Director, CGWB, Lucknow vide mail dated 27.7.2018 for confirmation on status of NOCs to respondents No. 5 to 126. The Regional Director, CGWB has replied vide mail dated 30.7.2018 that only respondent No. 100(Country Inn, Sahibabad) has valid NOC and none other have applied for NOC as on 30.7.2018.

Now the Hon'ble Tribunal vide order dated 31.7.2018 has directed CGWA and Jal Nigam to furnish the factual report. Hence you are requested to kindly confirm as to whether the respondents No. 5 to 126(except R/100) are drawing water from UP Jal Nigam source or drawing ground water. If the concerned respondents are drawing ground water without a valid NOC from CGWA the illegal bore-wells are required to be sealed/Electric supply to bore-wells disconnected (as per the directions of Hon'ble NGT) with advice to apply for NOC for ground water extraction if any. The Hon'ble Tribunal has directed to file report on or before 31.12.2018. Hence a show cause notice may also be given at your end to Respondents No. 5 to 126(except

respondent No. 100) with 15 days time to offer explanation. Kindly confirm the status on ground water use and action taken at your end.

In reference to the above, Hon'ble National Green Tribunal in O.A. no. 438/2018 Arti Versus CGWA & Ors passed order on 10.09.2021 which is as below:-

Report dated 31.12.2018 has been filed only on 10.09.2021 without any narrative by the CGWA. The report merely annexes a letter of the District Magistrate, Ghaziabad dated 31.12.2018 in respect of 15 hotels which were inspected and found extracting water illegally. It is stated that the bore wells of the said hotels were sealed .

When we have taken up the matter today, learned counsel for the CGWA has no information , why only 15 hotels have been inspected , why the report of 2018 was filed only in September ,2021 and what is the current status

.....We direct the CGWA to place the complete the information on record about the status of compliances by the concerned parties. The CGWA may interact with the District Magistrate and state PCB about the remedial measures for compliances of law and take further action , following due process, in exercise of statutory regulatory powers of the CGWA and other Authorities, including District Magistrate and state PCB.
