MAGISTRATE (EAST) BEFORE THIS HON'BLE TRIBUNAL IN TERM OF
ORDER DATED 08.01.2025

1. That Hon'ble Tribunal had pleased to issued direction vide dated 8.01.2025, directing therein that which is reproduced as under:

" 20..... all the Deputy Commissioners (Revenue)/District Magistrates in the National Capital Territory of Delhi are directed to file further compliance report as directed by this tribunal vide order dated 28.08.2024 with all relevant details at least three days before date of hearing fixed."
2. The Hon'ble Tribunal had pleased to issued direction vide dated 28.08.2024, directing therein that which is reproduced as under:

".....Further all the Deputy Commissioner (Revenue) of each revenue area in GNCTD were directed to upload with link on the main page of their respective websites under heading 'Groundwater Management' complete information regarding (i) complaints received regarding illegal borewells and action taken on the same, Minutes of the Meeting and recommendations of the District Advisory Committee regarding the same, (ii) references received for realization of environmental compensation and action taken for realization of the same and (iii) remedial measures taken for remediating environmental damage caused on the respective website of the District Administration by 30.09.2024,...."
3. That the District Magistrate, East, had taken all necessary and appropriate steps to ensure compliance with the directions issued by this Hon'ble Tribunal in the present matter. Also pursuant to the orders of this Hon'ble Tribunal,



the District-East Administration undertook requisite actions within the stipulated time frame and has duly complied with the directions issued. The compliance report may kindly be read as under :-

"It is submitted that in compliance with the direction issued vide the Hon'ble court of NGT vide order dated 28.08.2024, a link has been created on the main website to District Magistrate(East), for uploading the minutes of District Advisory Committee and Action Take Reports. (<https://dmeast.delhi.gov.in/documents/status-of-borewells/>).

- That the Delhi Jal Board has provided the list of 147 illegal Borewells. The Action Taken Report on the list provided is as on date is as under:-



5. Despite the challenges, concerted efforts were and are being made to comply with the directions of Hon'ble NGT in letter and spirit and 116 identified illegal borewells are sealed in District East, also 29 more borewells identified have to be sealed and delivery reports/SCN (Show Cause Notice) will be sent to DPCC for imposing EDC (Environment Damage Compensation). Due to the efforts substantial progress has been made in complying with the Hon'ble NGT's directions. Efforts are ongoing to resolve the pending cases and address issues such as incomplete addresses. Regular updates will be submitted to ensure transparency and adherence to the Hon'ble NGT's orders. (Copy enclosed as Annexure 'A')
6. That the imposition of costs in the present matter appears to have been made on the presumption of non-compliance; however, the compliance has been duly carried out in letter and spirit. However no list either from DPCC or from DJB for recovery of EDC (Environment Damage Compensation) has been received.



7. That it is again reiterated that the undersigned shall comply with the SOP for regulation of extraction of groundwater, closure, prohibition of illegal activities relating to use of bore wells/ tube wells.
8. That the undersigned is duty bound to follow the environmental rule of law embodied by statutory frame work regulating and managing extraction and recharge of ground water and fully committed and dedicated to the cause of protection and improvement of environment which is also constitutional obligation of the State and all its instrumentalities/officers/officials.

Based on the above facts, a report/reply is being submitted for kind consideration before this Hon'ble Tribunal. Undersigned assures that the orders/directions passed by this Hon'ble Commission shall be complied timely with in toto and spirit.


