Compliance of order dated 23.07.2018 and 20.11.2018 passed by the National Green Tribunal in OA No. 454 of 2018 (MA NO. 1092 of 2018) & Execution Application No. 52 of 2018 titled as Subhash Gupta and Others V/s Union of India.

1. Hon'ble National Green Tribunal has issued orders dated 23.07.2018 of which operative part is as under:-

"8. In line with the earlier decision of this Tribunal we have no hesitation in directing the Principal Secretary, Town & Country Planning Department of the State of Haryana in consultation with State Pollution Control Board and the Municipal Corporation, Gurgaon to take steps so that storm water drains are not covered. But are desilted and kept clean. It is not necessary to summon the said respondent as the matter is covered by earlier order. The State of Haryana may prepare an appropriate action plan or a scheme which may also provide for recovering specific amount for those who are found pollution the storm water drains. Such an action plan may be prepare within six weeks from today thereafter implementation thereof may be overseen by Respondent No. 2 consistent with the action so prepared. The action plan may be placed on its website giving liberty to concerned members of the public to give their views which must be taken into account in the monitoring process from time to time."

2. It is submitted that :-
 - a. All the master drains i.e. Leg-I, II & III (Badshahpur Drains) and drains along master roads and sector dividing roads are under the jurisdiction of Gurugram Metropolitan Development Authority and steps w.r.t. storm water drains being not covered is to be taken up by Gurugram Metropolitan Development Authority (GMDA).
 - b. Compliance of action plan w.r.t. desilting and repair of arterial drains falling within jurisdiction of MCG has been made and detailed attached as **Annexure-I**.

c. Action plan to prevent sewage from entering into master storm water drains i.e. Leg-I, II & III (Badshahpur Drain) has already been submitted in the form of affidavit in OA No. 06 of 2012 titled as Manoj Mishra and WP No. 375 of 2012-Paryavaran Suraksha Samiti Vs Union of India and latest status regarding the same has been submitted to the Gurugram Metropolitan Development Authority.
