

**STATUS REPORT IN THE SHAPE OF AFFIDAVIT ON BEHALF OF THE  
RESPONDENT/MUNICIPAL CORPORATION OF DELHI**

1. That the submissions made by the applicant in IA No. 700/2024 are categorically denied unless specifically admitted herein.
2. This report may kindly be read with affidavit dated 08.11.2024 filed in Ex. Application No. 15/2024.
3. That with reference to the booking details submitted by the petitioner in tabulated form in paragraph 2(ii)(d) of IA No. 700/2024, the correct details of bookings are enclosed as **Annexure-R1 (Colly)**.
4. That vide Order dated 13.09.2024, this Hon'ble Tribunal observed that the policy dated 07.09.2012 is not in consonance with the orders of the Hon'ble Supreme Court of India, and the deponent was directed to file a further status report. Accordingly, a status report dated **08.11.2024** was filed by the deponent. That the Respondent has also proposed a file before the competent authority for restricting the bookings of parks maintained by MCD, for a period of 10 days per month in respect of Religious functions such as Ramleela, Durga Puja, Ganesh Chaturthi, Bhagwat Katha etc, with an expectation of obtaining approval from the appropriate authorities to further solidify this restriction in consonance with Hon'ble Supreme Court directions.
5. That in para 3 of the Status Report dated 08.11.2024, it was already stated that a proposal for restricting the booking of parks for social, marriages and religious functions was mooted by the Horticulture Department through the Commissioner of the Corporation and it was placed before the Corporation through the Standing Committee. That vide Resolution No. 417 dated 09.03.2022, the proposal of the department for restricting booking of parks to 10 days in a month was rejected by the Corporation.
6. That park bookings from October 2023 to November 2024 were made in accordance with the policy dated 07.09.2012. However, as per paragraph 4 of the status report dated 08.11.2024, the deponent has already assured this Hon'ble Tribunal that strict compliance with the orders of the Hon'ble Supreme Court shall be maintained. From December 2024 & onwards, the Horticulture



Department, West Zone, has ensured that park bookings do not exceed 10 days per month. However, November 2024 bookings were made in advance and could not be retrospectively altered. The detailed booking records for December 2024, January 2025, and February 2025 (up to the date 28.01.2025) are enclosed herewith as **Annexure-R2 (Colly)**, demonstrating compliance with the 10-day limit from December 2024 onwards.

7. That Park Dussehra Ground is divided into three booking sites, namely FS/WZ/124/1, FS/WZ/124/2, and FS/WZ/124/3, which are each individually booked for social events. The remaining area, totaling 5734 sqm, is developed and maintained as a green space. The approved IDs for this park were reflected in Resolution No. 253 dated 25.03.2013. The copy of this resolution, reflecting the approved IDs of the park, is enclosed as **Annexure R-3 (Colly)**. That 13,099 sqm of the total 18,832 sqm area of this park has been utilized for hosting marriages and various other functions over the past many years. A proposal has also been moved for merging the three existing IDs, under which the Park Dussehra Ground was divided into three bookable sections for different parties. This step is intended to ensure that the park is used in a manner that adheres to legal directives and serves the public interest while preserving the environmental and recreational value of municipal parks.
8. That the allegation that the respondent has failed to comply with its circulars and did not impose fines is unfounded. The Horticulture Department, West Zone has taken appropriate action from time to time, which includes forfeiture of Security Deposits of booking parties in case of violations such as unauthorized occupation of the ground beyond the allotted dates, illegal parking, damage to the ground, non-removal of tents. The Security Deposits of various booking parties with park booking dates 12.10.2023 to 26.10.2023, 06.02.2024, 14.04.2024, 07.05.2024 to 20.05.2024, 14.07.2024, 30.09.2024 to 14.10.2024, 18.11.2024, 24.11.2024, and 01.12.2024 were forfeited on account of violations of park booking guidelines. The details of the forfeited security deposits are enclosed as **Annexure-R4(Colly)**.
9. Further, notices have been issued to various park booking parties to vacate the park as per the terms and conditions of their bookings. The notices caution the parties about the damages to saplings, removal of tents, and other violations of booking terms. Copies of notices dated 03.09.2024 (Ref. No. ADH/WZ/MCD/2024-25/D-801), 26.09.2024 (Ref. No. ADH/WZ/MCD/2024-25/D-931), 10.10.2024 (Ref. No. ADH/WZ/MCD/2024-25/D-987), 11.09.2024 (Ref. No. 851/ADH/DDH/WZ/MCD/2024), and 02.12.2024 (Ref. No. ADH/WZ/2024-25/216) are enclosed as **Annexure-R5(Colly)**.
10. Additionally, the Horticulture Department, West Zone has reported instances of violations to the local Police Station in writing which includes non-vacation of the ground, unauthorized occupation of the ground beyond the allotted dates, digging of pits for chhath puja etc. and also communicated with the Deputy Commissioner of Police and Assistant Commissioner of Police,



Rajouri Garden, for prioritization of complaints related to Municipal Parks. Copies of letters dated 17.09.2024, 19.09.2024, 20.09.2024, 25.09.2024, 26.09.2024, 27.09.2024, 15.10.2024, 04.11.2024, 06.11.2024, 18.11.2024, 26.11.2024, 29.11.2024, and 02.12.2024 are enclosed as **Annexure-R6(Colly)**.

11. The Department has also written letters dated 19.11.2024, 26.11.2024, and 02.12.2024 to the Delhi Pollution Control Committee (DPCC) for taking action on violations of unauthorized occupation of park, and noise and air pollution observed in Dussehra Ground Park. Same are enclosed as **Annexure-R7(Colly)**.
12. That the Park, namely Dussehra Ground is restored on regular basis by the Horticulture Department, West Zone by way of cleaning, leveling and peripheral plantation, ensuring that the park remains in good condition. It has also been submitted in the status report dated 08.11.2024 that peripheral plantation of 493 plants of various species such as Neem, Papdi, Peepal, Pilkhan, Molasri etc was carried out by the Horticulture Department, West Zone. The photographs of the various maintenance activities undertaken at site are enclosed as **Annexure-R8(Colly)**.
13. The incident involving unauthorized excavation on 04.11.2024 intended for the creation of a Chhath Ghat in preparation for the Chhath Puja celebration, a religious event. The Horticulture Department of the Municipal Corporation of Delhi (MCD) promptly arranged for a JCB to fill the excavated area. However, due to public resistance and interference from political parties, the operation had to be suspended. To address the matter appropriately, the Department immediately contacted local law enforcement via 112 (Reference No. 10151696) and lodged a formal police complaint with the concerned police station. Additionally, an email was sent to the Deputy Commissioner of Police, West Zone, on 06.11.2024, informing them of the situation. With respect to the issue of plastic sheet in the dugged up pit, it is mentioned that as per the report of Garden Chowdhary, the pit was itself filled by the party organizing the chhatt. The report dated 22/01/2025 received from Garden Chowdhary is enclosed as **Annexure-R9**.
14. That the applicant's contention that Ramleela and Dussehra events were organized without the requisite permissions is factually incorrect. The Casual Performance License was duly issued by the Office of the Joint Commissioner of Police (Licensing) in favor of Sh. Deepak Jindal. Additionally, all required NOCs were obtained from the relevant authorities. Copies of the same are annexed as **Annexure-R10(Colly)**.
15. That the Respondent remains committed to complying with the directives of this Hon'ble Tribunal and the Hon'ble Supreme Court of India regarding the regulation of park bookings and other related activities.



16. That the contents of this affidavit are true and correct to the best of my knowledge and belief, and no part of it is false, and nothing material has been concealed therein.

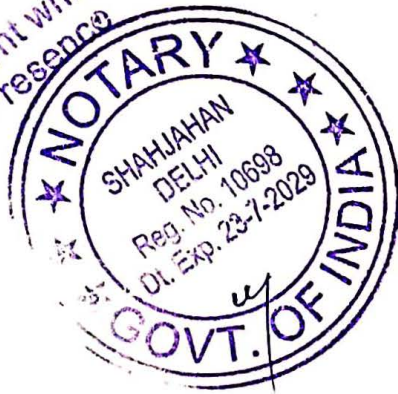

**Subject :—** Regarding proposal for creating new sites for booking for marriages etc. and approval of revision of rates and process of park booking etc.

(i) Commissioner's letter No. F. 33/Hort./SDMC/516/C&C dated 5-2-2013.

At present there are 6400 parks in SDMC and out of these 63 number of Sites (58 parks & 5 other sites) are allowed for holding marriages and other functions by booking online through CSB. (List attached at Annexure-I). It is worth mentioning that earlier in SDMC area there were more than 600 parks used to be booked for holding functions etc. Supreme Court of India in the matter of "M.C. Mehta Vs. Union of India and others" in WP(C) No. 4677/1989 has shown displeasure in respect of degradation of parks due to holding of marriages of etc. Hon'ble Supreme Court has also directed that "The use of parks by the MCD, the NDMC and the DDA for the purposes mentioned above shall not be permitted more than 10 days in a month. In other words, when any of the designated park is used for such purposes 10 days in a month, no function thereafter shall be permitted during the remaining 20/21 days".

Further, Court also directed that no tree shall be cut from any of the parks for any purpose, specially to facilitated holding of these functions etc. In the aforesaid matter court has agreed the view of Mr. Mehta (Applicant) that the recreational and other aesthetic uses of the parks cannot be curtailed. Also, that the permitted use of park was being recreation under the Master Plan, it cannot be permitted for any other use. But at the same time, keeping in view of the need of the society, it is necessary to bring the parks back to their normal use in a sustained manner.

In the recent judgment in the matter of RWA and others Vs Union of India and others in WP(C) No. 8582/2009 and CM No. 5665/2009, the Hon'ble High Court of Delhi closed 551 parks for holding marriages etc. and allowed holding marriages etc. in 144 parks only till December, 2014 in undivided MCD. The Court is mainly worried for degradation of parks due to holding of functions. Most of these parks are barren and lack green cover.

The Horticulture Department/SDMC has made a survey/inspection of the parks where functions are allowed and it was found that most of these parks are lying barren without any grass and shrubs etc. in the parks. It was also noticed that there are very less number of trees in these parks as compared to other ornamental/ordinary parks maintained by the department. It is proposed that these parks be converted into green landscape by planting trees in the periphery and maintaining green belt along the boundary so as to give aesthetic look to these parks. Mali will be deputed to maintain these parks during function days and thereafter during the days when function are not held. It will help in maintaining these parks as green. While planting these parks area will be earmarked for cooking and for use of generator during the functions. A Board showing the landscape plan of the sites will be placed in all these parks. Department will make sure that the above said plan of the park be complied with by the function organizers. In case of any damage, the department will recover the same from security deposit of the organizers. This effort will also help in complying the basic issue of court order i.e. preserving the green, recreational and aesthetic use of the land. Further these parks can be utilized by children for playing games, when these are not booked. It is to mention that due to closure of a large number of parks for holding functions the other parks are also being degraded, as functions are mainly held in night and there are no chowkidar in horticulture department.

Further there are vacant plots and other areas available in the zone which may not get developed in near future. These sites are otherwise not giving any revenue can be used for holding marriages etc for short durations (i.e. year to year basis).

In view of above background following is proposed :—

1. In all the parks which are being used for holding functions like marriage etc a peripheral green belt will be created with one row of tall trees leaving the space for gates. Where ever possible green lawns in the park will be created. These parks will be open for playing of children when not booked. The green belt with one row of tall trees will be created preferably in the coming Mansoon Season when it is not a marriage season.

2. The booking rates of parks and other sites were approved by the Corporation vide Resolution No. 113 dated 15-6-2010. Further the competent authority also approved the following which are also being followed, may be ratified :—

(a) Three Special Function Sites of Subhashi Nagar Chhatri Wala Park, Beri Wala Park and 3-Block Park were approved for booking @ Rs. 10,000/- were approved for booking @ Rs. 8,000/- per day for uniformity of rates with other parks.

(b) The special conditions mentioned in the preamble regarding disclosing the names of the tent house, fine for illegal occupation of parks and non park sites, opportunity cost of non park sites of Punjabi Bagh etc. were modified as follows :—

(i) The following fees may be charged for each day taken for installing, dismantling (minimum one day for installing and one day for dismantling or actual) and for keeping tent installed without permission :—

1.	Rs. 4,000/-	Rs. 3,000/-
2.	Rs. 8,000/-	Rs. 6,000/-

The booking charges will be paid by the party booking the park. Charges for installation and dismantling of the tent and any fine etc. will be paid by the Tent House/Tent Owner as per the actual days used/occupied.

(ii) If there is no function in the park but tent house is occupying the park, the fine will be same as are charges for installing and dismantling. However, if the function is being held on the site illegally/without permission, the fine will be three times the rate of booking of the park/function site.

(c) Security deposit were fixed Rs. 5,000/- and cleaning charges Rs. 1,000/- and license fee Rs. 500/- for parks being booked @ Rs. 4,000/- per day and @ Rs. 3,000/- per day.

3. The booking rates of the park may be enhanced as follows :—

- (a) The parks which are categorized as Function Sites and other sites like Punjabi Bagh Stadium which are being booked @ Rs. 25,000/- are proposed to be booked @ Rs. 37,500/- per day. Security Deposit (Refundable) is also proposed to be increased from Rs. 10,000/- to Rs. 15,000/-. Cleaning charges are also proposed to be increased from Rs. 1,000/- to Rs. 1,500/- and license fee of Rs. 1,000/- (unchanged).
- (b) The park being booked @ Rs. 8,000/- are proposed for booking @ Rs. 12,000/- per day with one time Security Deposit of @ Rs. 5,000/-, cleaning charges @ Rs. 1,000/- and license fee of @ Rs. 500/-.
- (c) The park booked @ Rs. 4,000/- are proposed for booking @ Rs. 6,000/- per day with one time security deposit of @ Rs. 5,000/-, cleaning charges of @ Rs. 1,000/- and license fee of @ Rs. 500/-.
- (d) It is to mention that rates regarding Security Deposit (Refundable), cleaning charges and License fee have not been changed for parks mentioned at SL No. (b) & (c) above.

4. It is proposed that each year in the month of August to September Horticulture Department in consultation with Community Service Department, Education, Land & Estate, Engineering Department etc. and area Councillor will identify the open spaces/plots etc. which are not developed and are not going to be developed or used for any project for next one year or which may be barren and devoid of trees and grass and which can be offered temporarily for booking for holding marriages etc. for next marriage season (i.e. till June & next year).

The rate of booking of such open spaces/plots/barren sites etc. for holding functions like marriages etc. may be fixed on following lines :—

(i) Rates for Small area (upto 0.5 acre) Rs.	(ii) Rates for Medium area (more than 0.5 upto 1.0 acre) Rs.	(iii) Rates for Large area (more than 1.0 acre) Rs.

The security deposit for sites proposed for booking @ Rs. 37,500/- will be @ Rs. 15,000/- with cleaning charges of Rs. 1,500/- and License Fee of Rs. 1,000/- in each booking. For the remaining areas Security Deposit will be @ Rs. 5,000/- The cleaning charges will be @ Rs. 1,000/-, in each booking and license fee @ Rs. 500/- in each booking.

Further, every year in the month of the September Horticulture Department will examine afresh these sites if they will remain available for booking during the next year i.e. if no project etc. will be coming in the areas or no developmental work is taking place during the next year then they may be continued for booking in the next year. Booking of open spaces etc. will help to increase the revenue and also it will be a help to the public.

For fixing the rates on above lines of the sites identified by the department a committee of two Dy. Directors Horticulture and one Assistant Director of Horticulture will be constituted and the rates and sites will be approved by the Commissioner, SDMC every year.

In Punjabi Bagh there are two such site which are being booked in five parts with present rate or booking @ Rs. 25,000/- per day and enhancement proposed as above.

Recently two more such sites have been identified :—

- (a) One in front of office of the Dy. Assessor & Collector, M.C. Primary School, Sawal Nagar, ward No. the area of this site is 0.25 and as such the rates of Rs. 6,000/- per day may be fixed for this site.
- (b) An area of 0.6 acres has been identified at Titar Pur Village Ward No. 105. As such the rates of Rs. 12,000/- per day may be fixed for this site.

5. The fees already being charged for installation and dismantling of tent by tent owners are also proposed for approval so as to be increase as follows :—

The booking charges will be paid by the party booking the park/sites. Charges for installation and dismantling of the tent and fine etc. will be paid by the tent owner as per actual days used and permission taken.

6. If there is no function in the park but tent house is occupying the park with permission the fine will be the same as are the charges for installing and dismantling as given in Serial No. 4 above. However, if the function is being held on the site illegally or site is occupied illegally (without permission) the fine will be three times the rate of booking of the Park/Function Site. This is being charged at present also.

7. These Parks and Function Sites are given Booking IDs as follows : FC/ZONE CODE/ WARD NUMBER/FUNCTION SITE NUMBER. In every ward FUNCTION SITE NUMBERS start from 1 and firstly all the parks being booked at the highest rates are numbered and so on. It is proposed that 10 for the open spaces which are, temporary booking sites may be given similarly except the function site number should start from TEMP1 beginning with the highest priced site of the ward.

8. The detailed existing guidelines for booking of parks etc. are given at Annexure-II. All sites will also be booked as per these guidelines.

9. All the Sites (including parks) will be booked following above guidelines contained in this preamble. All these guidelines as above which were in practise in past regarding rates, fines etc. and which has been modified in this preamble may be approved in supersession of all the past guidelines and resolutions regarding booking of parks and other sites. These approved guidelines will also be applicable for other sites etc. If any dispute arises regarding interpretation of the rules the same will be referred to Commissioner, SDMC for resolving and his decision will be final.

The matter may be placed before the Corporation through the Standing Committee for approval considering it an Urgent Business, as SDMC will start getting more revenue once it is approved.

## ANNEXURE 'II'

## Guidelines for booking :

1. Parks will be booked for Private Functions 10 days in a month. There will be no such bar for non-park sites.
2. The rate of booking of parks/non-park site will be valid if booking is made within three months prior to the date of function. If booking of park/non-park site is made much in advance then following rates will be charged :—
  - (i) If made within 3-6 months in advance, double of booking charges.
  - (ii) If made within 6-9 months in advance, triple of booking charges.
  - (iii) If made within 9-12 months in advance, four times of booking charges.

## Booking Procedure :

3. The booking will be done at CSB Counter.
4. For booking a park the consent of the Area Councillor or the consent of Honourable Mayor is required.
5. The consent of the Area Councillor/Mayor will be valid for five days for a particular date of booking and if the applicant does not get the booking done in five days then the site (place of function) would be given to other needy applicant.
6. If available for booking, the citizen has to submit the booking amount (includes park rent, license fees, refundable security charges, cleaning charges and service tax) and necessary documents to CSB operator.
7. The SDMC Staff (Horticulture or UDC) posted in CSB will check all the documents and will recommend to CSB Supervisor for booking.
8. Documents :—
  - (i) Affidavit of Rs. 10/-.
  - (ii) ID Proof (includes PAN Card/Voter's ID Card/ Passport/License/Ration Card/Aadhar Card).
  - (iii) Invitation Card.
  - (iv) Demand Draft in favour of the Commissioner, SDMC for security deposit (refundable).
  - (v) Photographs of bride and groom.
  - (vi) Consent/NOC of the area Councillor/Hon'ble Mayor.
9. G-3 will be issued and park is booked.
10. The parks may be booked for holding the marriage or other functions of son/daughter/real sister/real brother of the SDMC staff free of rent. He/She will have to deposit Security Deposit, License fee and Cleaning charges. He/She will deposit all the required documents as mentioned at Sl. No. 8 above along with a recommendation letter from his/her Head of the Department.
11. Security Deposit will be taken in the form of Demand Draft in favour of the Commissioner, SDMC. The security will be released in full or in part after successful completion of the function within 15 days by the Dy. Director (Hort.) of the Zone.

## 12. Refunds :

The refund will be done by the Deputy Director Horticulture ( )

Refunds can be made for :-

- (a) Cancellation of Booking.
- (b) Security Deposit Refund.

Any request for postponement/advancement of booking made would be treated as cancellation.

## 13. Methodology for Cancellation of Booking :

- (a) Citizen will apply to Zonal DDH/AO for cancellation.
- (b) The original G-3 and ID proof submitted at the time of booking, needs to be submitted.

Guidelines/Rules for Cancellation refund:

- (a) If cancellation done within 7 days of function date (function date excluded)

- (i) Refund 100% Security Deposit.
- (ii) Refund 25% Park Rent.
- (iii) Refund 100% Cleaning Charges.

- (b) If cancellation done in more than 7 days of function date

- (i) Refund 100% Security Deposit.
- (ii) Refund 100% Park Rent.
- (iii) Refund 100% Cleaning Charges.

## 14. Methodology for Security Deposit Refund :

- (a) The citizen has to submit an application alongwith G-3 Receipt issued at the time of booking to the Zonal DDH.

- (b) Application should be in the name of Deputy Director Horticulture of the Zone.

- (c) If MCD has to recover any damage etc. from the security amount then the concerned Section Officer of the MCD will have to submit a report to the Dy. Director (Hort.) concerned within seven days from the date of completion of function and which will be processed by the DDH immediately. If no such report is furnished by the concerned Section Officer within seven days to the DDH concerned then it will be released to the party. If later on due to non-submission of report of Section Officer any damages are found the same will be recovered from salary of the concerned Section Officer.

- (d) To Collect the demand draft from Dy. Director Horticulture of Zone within 15 days.

- (ii) Resolution No. 244 of the Standing Committee dated 5-3-2013.



Sir,

The Horticulture Department of MCD is responsible for maintaining greenery, ensuring proper pruning, and managing the booking of municipal parks for social and religious functions. These duties are vital for preserving the city's environmental health and supporting community activities.

Being responsible for maintaining greenery, the Horticulture Department frequently encounters scrutiny from the Hon'ble National Green Tribunal (NGT) and other judicial forums. During these proceedings, the Hon'ble Tribunal and Court often inquire about the status of complaints and FIRs filed with the police for various issues related to pruning, installation of tents in parks without permission, cutting of trees etc. The inability to provide satisfactory updates or evidence of complaint registration has led to complications and criticisms, impacting the department's credibility and operational efficiency.

It has been observed that officials from the Horticulture Department, West Zone, MCD, face repeated difficulties in registering complaints at various police stations due to non-entertainment. This situation adversely affects the department's operational efficiency and its ability to fulfill its public service obligations.

When FIRs are registered, there is a concerning pattern of registration under incorrect or irrelevant sections of the law. For example, in FIR No. 80096511 dated 01/09/2024, the complaint concerned unauthorized erection of tents by Divya Jagarti Sanstha. Rather than being addressed under appropriate legal provisions related to unauthorized activities or public nuisance, the FIR was registered under theft/stolen sections of BNS, 2023, specifically Section 303(2). Such misclassifications hinder the resolution of legitimate issues and undermine procedural accuracy. Copy of one such FIR is enclosed.

This communication serves to bring to the attention of the Delhi Pollution Control Committee (DPCC) the issue of unauthorized occupation of Dussehra Ground (also known as **Bharpai Devi Jindal Vatika**) located at F-Block, Vikas Puri in the West Zone of the Municipal Corporation of Delhi (MCD). This park (less than 5 acres in size) was officially booked by the Horticulture Department of MCD for the date 01/12/2024. It has been observed that the park is still occupied beyond the prescribed booking period which was 01/12/2024, causing significant damage to the park's infrastructure and the surrounding environment.

As per the **Hon'ble Supreme Court's** guidelines, the park can only be booked for a **maximum of 10 days per month** for events. However, it has come to notice that the tent owner is consistently exceeding this limit, keeping the park occupied for extended durations. This continued overuse has resulted in considerable damage to the park, harm to trees, and overall environmental degradation.

In addition to this, concerns regarding **sound pollution** due to loud DJ music and the use of **firecrackers** during these events have been raised. These activities are

in violation of noise pollution regulations and environmental standards set by the **National Green Tribunal (NGT)** and the Supreme Court of India.

The concerned authorities of police (both local police & traffic police) and other civic agencies shall ensure on ground that the licensee is adhering to their guidelines/conditions stipulated while issuing certificates/NOCs/Clearances.

In case of Ramleelas with joy rides, local police shall ensure that joyrides are not operated till all the additional clearances are obtained in terms of structural stability/safety and electrical safety of such joy rides by the organisers for safe & secure operations. If any NOC/clearance certificates/booking slip/Fitness Certificate for joyrides not received before start of the event, the license shall deemed null & void.



CHECK LIST FOR INSPECTION TO EE(AUTO) & INSTRUCTIONS TO THE OWNERS OF TEMPORARY JOY RIDES WITHIN THE JURISDICTION OF MCD.

This is with reference to the directions given in the meeting held on 29-08-2022, chaired by the Addl. Commissioner (Engg.)/MCD to facilitate the process of granting permission to hold religious function such as Ramleela. As directed by the higher authorities, the check list for inspection of the joy rides and instructions to the owners of Joy Rides / Joy Rides Association in the light of the 'Instructional Order' of the Commissioner, MCD vide no. 1138/AC(CSE)/2001 dated 24-09-2001 and Covind-19 norms, are prepared. As the joy rides are not installed at the time of clearance to be given by the Delhi Police (Licensing), based on the fitness certificate from Municipal Corporation of Delhi, it is not feasible to give fitness at that point of time without inspection by the concerned officer(s) of MCD. However, following advices to be followed by the officers & Joy Rides owners :-

- 1) The fitness certificate shall only be issued by the Executive Engineer (Auto) of the zone under whose jurisdiction the location of Joy Rides falls.
- 2) Separate certificate shall be issued for temporary and permanent joy rides clearly indicating the type of Joy Ride, duration of its functioning & location of the Joy Rides.
- 3) The fitness certificate shall only be issued to Delhi based Joy Ride Association Members or to firm based in Delhi.
- 4) A certificate should be taken from the owner of the Joy Rides that the Joy Rides / jhula in question, is free from any risk / hazard and he will be responsible for its proper routine maintenance and any mishap due to lack of it will be the responsibility of Joy Ride owner.
- 5) The Joy Rides should be tested on full load before issuance of Fitness certificate.
- 6) A certificate from the owner / operator of the joy rides / jhula be taken that the safety precaution as prescribed by the manufacturer and any other agency are being observed by them.
- 7) Proper oiling, lubrication on the journal, bearing, moving supports, wheel axle, sliding parts, etc. wherever required should be done as per the guidelines of the manufacturer.

- 8) The owner shall ensure the fixing of proper foundation bolts & fasteners of all the joy rides by using the appropriate size & shape of the bolts, studying the quality of earth / concrete, number of bolts required to withstand the load of riders and joy rides and adequate depth of the installation of foundation bolts.
- 8) Every operator deployed on the rides should be well trained technically, operationally, about public safety as well and precautionary measures be taken after stringent training. Daily inspection reports / records of all the joy rides be maintained by the owner of the joy rides.
- 9) The owner should understand, respect and support the decision of the Government and the Local bodies in preventing the spread of COVID -19.
- 10) The owner of the joy rides / Amusement Company to ensure easy movement and safety of the public by maintaining proper gap. Owner should arrange for display of safety measures on each Joy Ride.
- 11) It is to be ensured by the owner of the temporary joy rides that there is proper balancing of all the pulleys, shafts, belts and belt-joints. Owner should check on routine the condition of ropes, locking pins, Teflon wheels, rubber wheels as well as physical and mechanical strength of structures by full load testing.
- 12) Erection of the seats / palki should be done with the good material such as ISI marked standard steel, suitable Fiber, etc. There should be no rusting, fracture, hole etc. on any of the seat, arms, floor, foot rest, struts, columns, shafts and structure.
- 13) Owner of the Joy Rides should ensure proper working of Safety Belts & all locks for the customers / riders.
- 14) The owners will provide all safety measures and will take all precautions for the operations of the rides for the visitors. In case of any untoward incident, accident, mis-happening, unforeseen event etc. which may cause any injury, casualty etc. to any visitor, the owners will be fully liable for such consequences and the MCD will not be held liable or responsible in any manner. Any negligence on account of the staff/ workers of the owners shall be the sole responsibility of the joy rides owners.

- 15) Perfect safe plan for evacuation of public during stampede, if occurs any be made and ensured by the owners of joy rides. Marking of exit path in the joy rides area also be done by the owners.
- 16) No unwanted noise in the joy rides area be maintained and operational noise should be within the permissible limits in order to maintain any such noise pollution. Owners must adhere to the Govt. rules & regulations.
- 17) Third party inspection report / technical inspection report of the joy rides / their assemblies from the manufacturer of the joy rides be examined, if any.
- 18) No electrical leakage & proper insulation of all the circuits, wire-joints & wire harnesses be ensured by the owners.
- 19) Owners of the joy rides shall maintain adequate first aid arrangements at the premises where joy rides are installed.
- 20) Mini joy rides for kids be installed at the places, free from any hindrance due to the movement of the other joy rides / visitors and proper space for visitors / parents of the kids be ensured by the owners.

Sir,

With reference to letter no. A2024090402137 dated 09.09.2024 on the subject cited above; it is informed that in case pandal is erected at site, the same shall be in accordance with the provisions of The Delhi Fire Service Act, 2007 and The Delhi Fire Service Rules, 2010. Fire prevention and fire safety measures in the Pandals to be self regulatory and shall include access to panda l, open space around the pandal, distance from medium and high voltage electrical wires and hazardous installations, means of exits, material of construction, first-aid fire fighting arrangements, water storage for fire fighting, electrical wiring, availability of trained fire fighting staff in accordance with IS 8758 and National Building Code of India published by Bureau of Indian Standards, New Delhi. The section 26 (2) of the Act 2007 read with Rule 30 provides that the erector of the pandal shall display a declaration in the prescribed format as per form "D" at a prominent place in the pandal. Under section 26 (4) of the Act, any erector of a pandal who falsely declares that he has complied with the prescribed fire prevention and fire safety measures in the Pandal, shall be deemed to have committed an offence punishable under section 52 of the Act. Accordingly, the above said programme may be allowed. However, following conditions shall always be adhered to:

1. Trained fire personnel shall always be available at the site during function.
2. All exits should always be clear and there should be no obstruction in the exits / entrance gate.
3. No special effects creating fire / crackers should be used at site.
4. LPG/Open flame should not be used for preparation of foods / stalls in the premises.
5. Permission for joy rides shall be obtained from concerned authority.

Any loss of life and property due to not following the above said conditions, the management / organization shall be responsible solely.

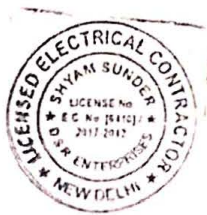
