According to previous report in Tehsil-Bara, surprise inspection of 13 other brick kilns was done, out of which 8 brick kilns have obtained consent from Uttar Pradesh Pollution Control Board. 05 brick kilns have not obtained the consent from the Uttar Pradesh Pollution Control Board, although the said brick kilns were not found operating at the time of inspection. Therefore, closure order has been issued on

25.01.2023 against 5 brick kilns, out of which 02 closure order revoked and current status is as follows :-

According to previous report in Tehsil-Meja surprise inspection of 17 brick kilns was done, out of which 13 brick kilns have valid consent from Uttar Pradesh Pollution Control Board. 04 brick kilns have not obtained the consent from the Uttar Pradesh Pollution Control Board, although at the time of inspection, said 04 brick kilns were not found operating. Therefore closure order has been issued on 25.01.2023 against 4 brick kilns which name & address are as below with current status:-
