



**STATUS REPORT IN TERMS OF ORDER DATED 02.12.2020 BY
DELHI POLLUTION CONTROL COMMITTEE:**

1. That this Hon'ble Tribunal took up the above referred matter on 02.12.2020 and pleased to direct *“let the Commissioner, EDMC and the Member Secretary, DPCC verify the facts and take remedial action, following due process of law. The nodal agency will be the Member Secretary, DPCC for coordination and compliance”*.
2. That, in compliance of the orders passed by this Hon'ble Tribunal, DPCC officials along with officials of Karawal Nagar, SDM conducted joint inspections in the Sonia Vihar-Sabhapur area on 04.02.2021. 130 premises were inspected by the team, out of 130 premises 128 premises are being used as godown. The detailed status of 130 premises which were inspected by the joint team is annexed as **Annexure-I**.
3. It is submitted that, in 02 premises i.e. **M/s Rajkumar Mathur/Sheetal International, GF, KH No. 15,5-1/2 Pusta, Sabhapur, Delhi-110094** and **M/s Mount Fresh Mineral water, H.No. 52, KH No. 610/613,5-1/2 Pusta Sabhapur, Delhi-110094** activity of Bottle cleaning and water packaging in pouch were observed respectively. Both the units were operating without mandatory permissions.

4. It is further submitted that both the units have been issued closure directions on 24.02.2021 and sealed on 02.03.2021. Copy of the sealing order is enclosed as **Annexure-II**. Show cause notices have been issued for imposition of EDC of Rs. 01 lakh on each unit.
5. The list of the premises inspected has been forwarded to the Commissioner, EDMC and SDM (Karawal Nagar). Copy of the letter is enclosed as **Annexure-III**.
6. It is also submitted that a strict vigil is being kept in the area by conducting regular inspections by DPCC.

The present action taken report may kindly be taken on record.
