

STATUS REPORT ON BEHALF OF MUNICIPAL
CORPORATION, FARIDABAD IN COMPLIANCE
OF ORDER DATED 20.11.2019 PASSED BY
THIS HON'BLE TRIBUNAL IN THE ABOVE
MENTIONED MATTER

1. That this Hon'ble Tribunal in the above matter vide its order dated 20.11.2019 passed the following directions :

"2. Having regard to the averments in the application, we find it necessary to require a joint report from the Municipal Corporation, Faridabad, District Magistrate, Faridabad and the DFO, Faridabad before the next date by email at judicial-ngt@gov.in. The nodal agency will be the DFO, Faridabad for compliance and coordination.

3. A copy of this order be sent to the Municipal Corporation, Faridabad, District Magistrate, Faridabad and the DFO, Faridabad by email.

4. The applicant may furnish a separate set of papers to the Municipal Corporation, Faridabad, District Magistrate, Faridabad and the DFO, Faridabad and file affidavit of service within one week.

List for further consideration on 30.01.2020."

2. That with respect to issues as mentioned in the original application about encroachment by private respondents impleaded herein, submissions are being made as follows:-

(1) It is submitted that Municipal Corporation, Faridabad takes strict action against the encroachments in green belts maintained by the Corporation in regular manner. The encroachments made by the respondents Manav Rachna International Institute of Research and Studies, Manav Rachna International School, Modern Vidya Niketan Schools and Aravali International School at Surajkund Road have been removed in presence of XEN Enforcement and Joint Commissioner, NIT, Faridabad on 20.03.2020. The action taken report and some of the

photographs of the demolition drive are attached as Annexure-R/1 to R4.

- (ii) It is humbly submitted that Municipal Corporation, Faridabad also provides assistance to other departments as and when requested or directed for removal of encroachments in the larger public interest.
- (iii) It is submitted that encroachment of about 3 acres green belt area as alleged by the applicant by Escorts company situated in Sector 12 & 14 dividing road, BPTP Chowk, Faridabad comes under the jurisdiction of H.S.V.P. (Haryana Shehri Vikas Pradhikaran). Accordingly, Estate Officer H.S.V.P., Faridabad was requested to remove such encroachment from the green belt.
- (iv) That the Sub Divisional Engineer, Survey Sub Division, H.S.V.P, Faridabad vide his office memo no. 1362 dated 02.07.2020 has informed that the unauthorized parking has been removed by the H.S.V.P. Horticulture Department and has planted greenery at site on 02.07.2020. A copy of letter dated 02.07.2020 and photographs sent by H.S.V.P. are attached as **Annexure R/5 & R/6**.

It is respectfully prayed that in view of the submissions made herein above, the present report may kindly be taken on record. It is being undertaken that directions passed by this Hon'ble Tribunal, shall be complied with sincerely.

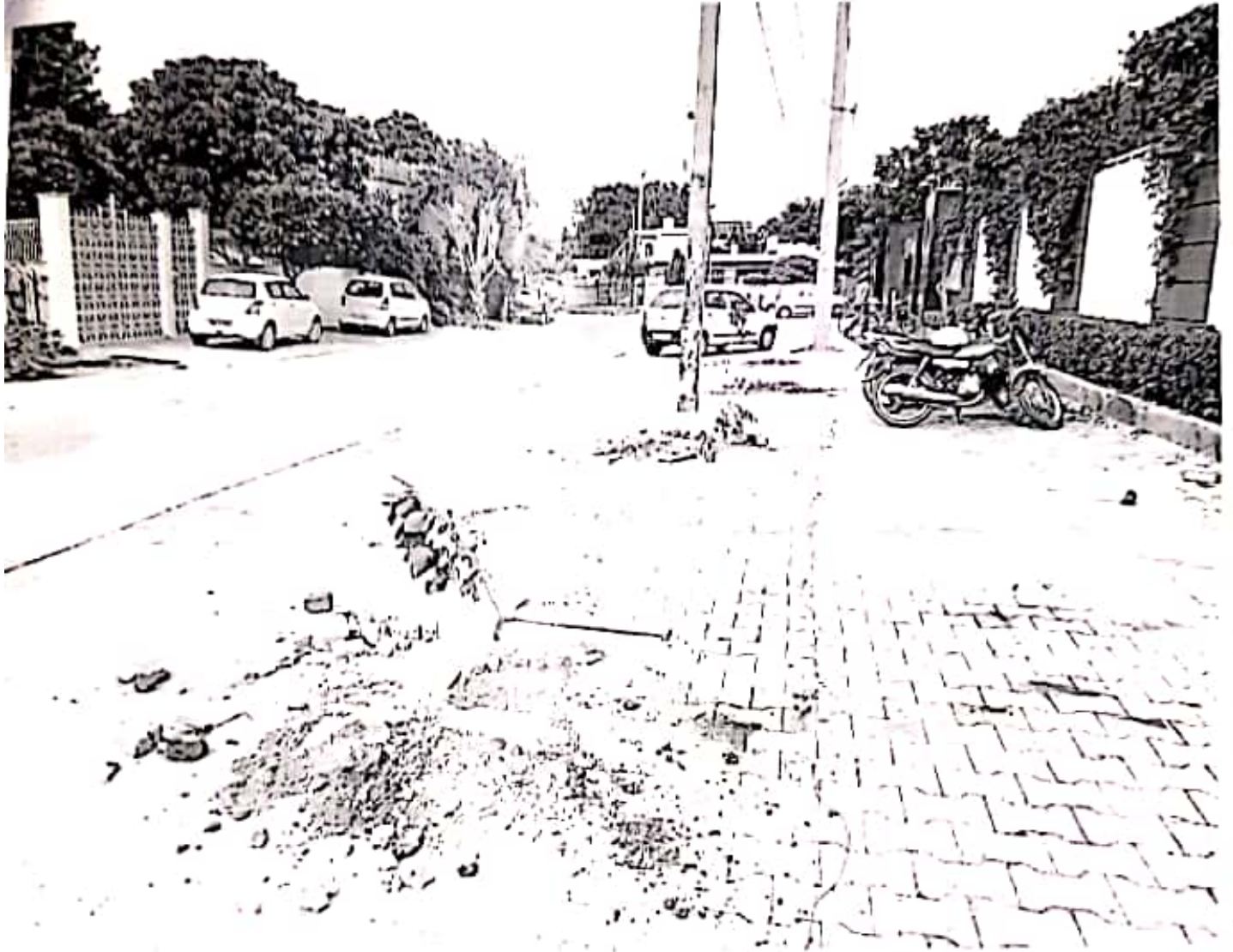

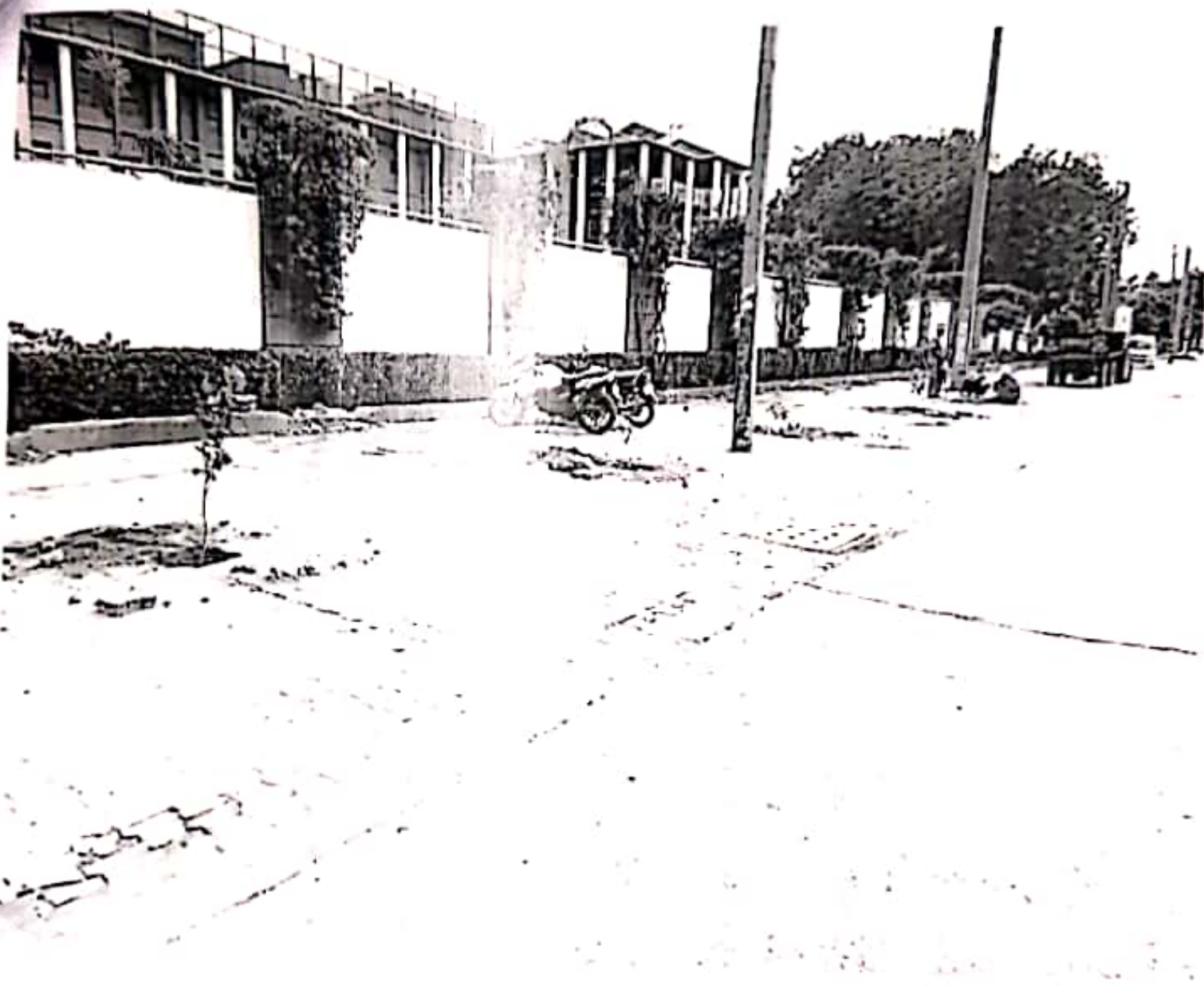

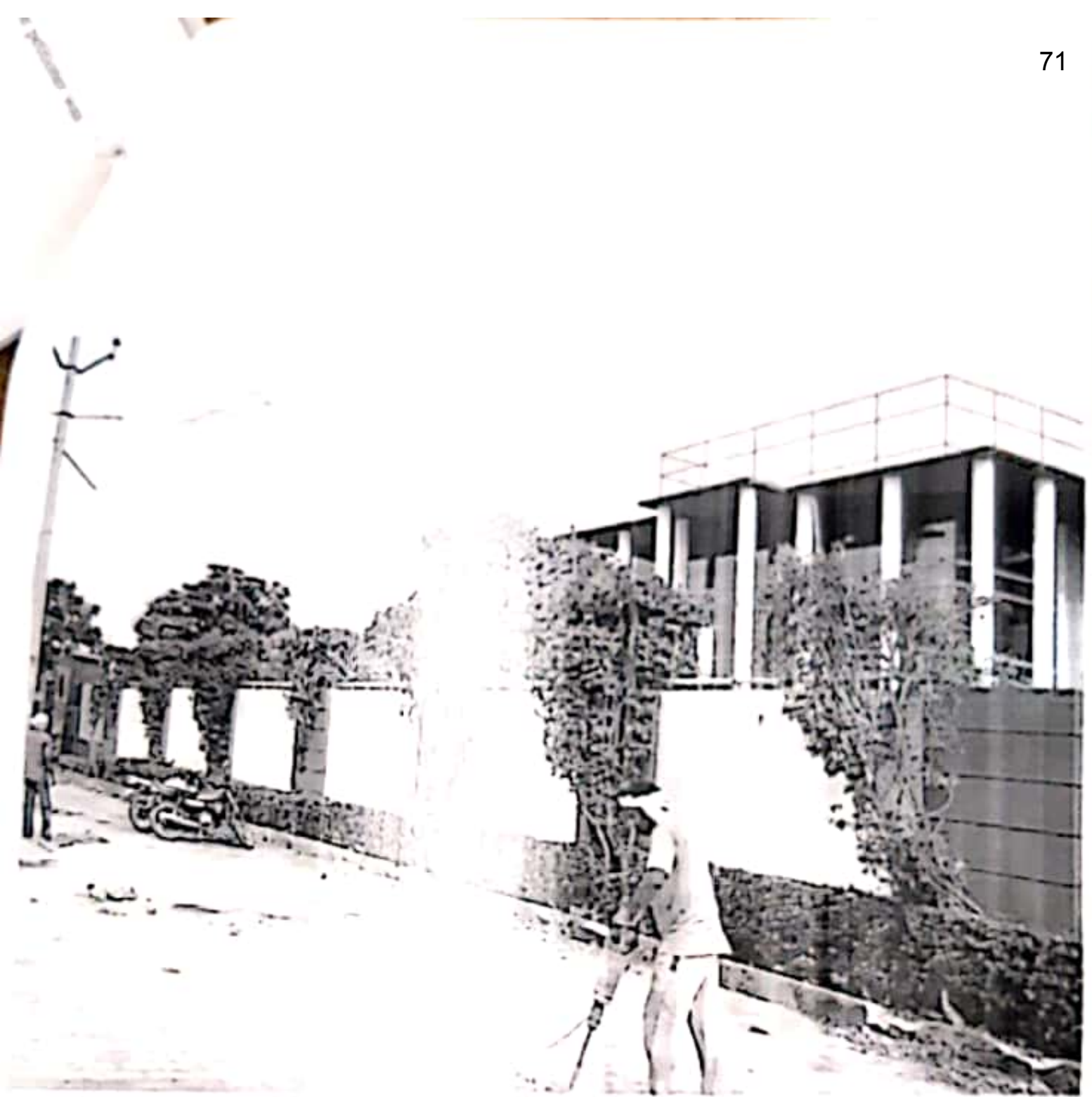
