1. The present status report is being filed on behalf of the District Magistrate (North Delhi) in response to the notice issued by this Hon'ble Tribunal in the captioned matter.
2. Upon receiving the information in respect of the fire incident at Narela, the District Magistrate immediately mobilized a response team as per the Emergency Support Functions protocol. A list of the ESF utilised is annexed hereto as **ANNEXURE A-1**.
3. Thereafter, forthwith an interim report was prepared by the office of the District Magistrate along with a list and details of the 20 affected persons of whom, at the time, 3 were already deceased. A copy of the interim report along with the said list is annexed hereto as **ANNEXURE A-2**.
4. That on 01.11.2022, the SHO (Narela) furnished an incident report along with a list of the deceased persons. A copy of the said incident report is annexed as **ANNEXURE A-3**.

- 5. The District Magistrate then issued letters on 09.11.2022 to the Officer Incharge (Fire Department), SHO (Narela Industrial Area), SDM (HQ)/DDMA (North), Medical Superintendent of SRHC seeking a factual report in respect of the fire incident.
- 6. Pursuant thereto, the SRHC Hospital submitted its response on 11.11.2022 respectively whereunder a detailed list of deceased persons and injured persons was furnished. Copy of the response dated 11.11.2022 is annexed as **ANNEXURE A-4**.
- 7. Whereafter, on 18.11.2022 an order was issued by the Sub-district Magistrate (Narela) bearing no. F.No.SDM/NL/Mis./2022/18885-86 requesting the details of the deceased and injured persons, their Bank Account details, Photo ID proof, proof of age, proof of relationship etc for the purpose of disbursement of compensation. A copy of the said order dated 18.11.2022 is annexed as **ANNEXURE A-5**.
- 8. The said details of the deceased and injured persons were submitted on 19.11.2022 by the SHO (NIA) vide communication No.4134R/SHO/NIA/OND/. It has also been informed that the investigation is still underway. A copy of the said communication dated 19.11.2022 is annexed as **ANNEXURE A-6**.



INCIDENT REPORT

Respected Sir,

A PCR call vide DD No. 23A was received at PS NIA regarding incident of fire inside a factory premises near JP Dharm kant. the same was marked to ASI Vikash for necessary action. ASI Vikash reached at the spot i.e. factory No. E-909 DSHDC Narela with staff and found that fire had spread on the first floor of the factory. Fire tenders were also present on the spot. Due to the fire, 18 people got injured and two persons have been declared dead. In this regard, the above mentioned case/ FIR was registered and further investigation was handed over to the Inspr. Girish Chandra. During investigation, the supervisor of the factory namely Vashudev S/o Shukr Yadav and owner of the factory is Sahil S/o Krishan Garg r/o C-2/72 Pitampura Delhi have been arrested. During Treatment four person expired. Remaining persons under treatment admitted in Safdurjung Hospital and RML Hospital, Delhi. (List of Deceased persons enclosed herewith)


