Uttar Pradesh Pollution Control Board Response in compliance of order dated 06.10.2022 passed by Hon'ble National Green Tribunal, New Delhi in the matter of O.A. No. 596/2022 Deepapal Vs. State of U.P. & Ors.

1. That it is submitted that in above stated matter Hon'ble NGT, New Delhi in OA No.- 596/2022 Deepapal Vs. State of U.P. & Ors. passed an order dated 19.09.2022 to constituted a Joint Committee comprising of State PCB, District Magistrate, Kanpur Dehat and direct the committee to meet, undertake visits to the site, look into the grievances of the applicant, associate the applicant and representative of the concerned project proponent, verify the factual position and submit its report within one month.
2. That in compliance of above direction, the Joint Committee has filed its report on 24.11.2022. After taking cognisance of the report of Joint Committee, Hon'ble NGT has passed the order dated 06.10.2023. The operative part of the order is reproduced as below :

..... 1. This matter relates to the allegation of violation of environmental norms by the brick kilns at Kanpur Dehat, Uttar Pradesh.

2. This Tribunal has passed a detailed order in connected OA 889/2022 today after considering the report filed by the UPPCB.

3. Learned Counsel appearing for the UPPCB has prayed for further time to file a fresh report in this matter also in terms of order passed in OA No. 889/2022. The prayer is allowed.

4. List on 21.12.2023.

3. That it is submitted that as per the report dated 24.11.2022 of Joint Committee, M/s Shakti Brick Field, Village- Maukhas, Vikas Khand-Amarudha, Tehsil- Bhoginipur, District- Kanpur Dehat M/s Shakti Brick Field Village- Maukhas, Vikas Khand-Amarudha, Tehsil- Bhoginipur, District- Kanpur Dehat Uttar Pradesh has been established in the Year 1991 and brick kiln obtained its first Consent to Operate from UPPCB on 06.02.2007. As the Brick Kiln is established prior to the Uttar Pradesh Brick Kiln (Site Criteria for establishment) Rules 2012 dated 27.06.2012. Therefore the District Panchayat by law will be applicable on the above brick kiln, which was followed by M/s Shakti Brick Field.

4. That it is submitted that M/s Shakti Brick Field is having valid CTO under Section-21 of Air (Prevention & Control of Pollution) Act 1981 and Water (Prevention & Control of Pollution) Act 1974, which are valid up to 31.07.2025. The Brick Kiln was based on natural draft-based firing emission technology, which is using coal as fuel by approx.- 03 TPD. At the time of inspection of joint committee, stack of the Brick Kiln was found damaged due to lightning fall on the stack and its maintenance work was under progress at speed. During inspection joint committee directed for providing emission monitoring port hole with safety as per CPCB Emission Regulation Guidelines. Annexure No.-1

District Agriculture Officer Kanpur Dehat vide letter dated 05.11.2022 was informed that no damage to the crops was found by the said Brick Kiln. Labour Enforcement Officer Kanpur Dehat has informed vide letter dated 04.11.2022 that no Child Labour was found during inspection of the said brick kiln. Mining Officer Kanpur Dehat informed vide letter dated 04.11.2022 that no illegal mining is done by M/s Shakti Brick Field in the area. SDM Bhoginipur Kanpur Dehat vide letter dated 07.11.2022 informed that Brick Kiln is established since 1991 and at that time human habitation was distance of 218m from the brick kiln. Also, M/s Shakti Brick Field had neither occupied the part of Chak Road nor any damaged is caused to chak road by activities of Shakti Brick Field.

The recommendation of Joint Committee in its report dated 24.11.2022 are as follows :

- i. The brick kiln should complete the maintenance work of stack along with arrangement for monitoring of flue gas from the stack as per the CPCB Emission Regulation Guidelines prior to start of next season at least before one week.
- ii. The brick Kiln should install water metering device at the bore well and maintain logbook of fresh water consumption with immediate effect.
- iii. The brick kiln shall construct/install wind breaking wall of 03 meter height around the premises without delay.
- iv. The brick Kiln should without delay develop an adequate green belt along the periphery of brick kiln for control of fugitive emission as well as dust control.
- v. The brick kiln should make arrangement for the treatment of domestic effluent and for this purpose prepare project report should be submitted within 15 days.


- vi. The brick kiln should submit time bound action plan within a month for compliance of Notification GSR 143(E) dated 22.02.2022 issued by MOEF & CC, Govt of India.
5. That it is submitted that UPPCB vide letter dated 31.10.2022 & 14.11.2022 had issued direction u/s-21 of Air (Prevention & Control of Pollution) Act 198 to M/s Shakti Brick Field Village- Maukhas, Vikas Khand- Amarudha, Tehsil- Bhoginipur, District- Kanpur Dehat Uttar Pradesh to ensure compliance of conditions mentioned in CTO Air & Water granted to the said Brick Kiln.
6. That it is submitted that officials of Regional Office, UPPCB, Kanpur Dehat has inspected the brick kiln on 07.12.2023. During inspection, unit was found not operational. During inspection it was found that Zig-Zag based trench is under construction and Stack Height of Chimney was found 30 m from GL as per rule.
7. That it is submitted that Brick Kiln make an arrangement for the treatment of domestic effluent by soak pit/ septic tank, wind breaking wall was under construction, development of green belt around the periphery of kiln was in progress. Brick kiln owner submitted an undertaking to comply the direction given by the Joint Committee before commencement of brick kiln. Annexure No.-2
8. That as per the direction of Hon'ble NGT vide order dated 06.10.2023, it is submitted that in District- Kanpur Dehat there were 250 brick kilns identified, out of which 28 brick kilns are closed by UPPCB and rest 222 Brick kilns have valid Consent to Operate (CTO). The list of 28 not operational brick kilns and 222 operational brick kilns are enclosed herewith and marked as Annexure No.-3
9. That U.P. Pollution Control Board has sent a letter dated 20.11.2023 to Superintendent of Police Kanpur Dehat and District Magistrate Kanpur Dehat and concerning SHO for ensuring compliance of closure order issued to the Brick Kilns units by the UPPCB. The copy of the letter dated 20.11.2023 is enclosed herewith and marked as Annexure No.-4

Therefore, the response of the UPPCB is being filed for the kind perusal and consideration of this Hon'ble Tribunal.
