(a) In this regards it stated that a complaint was received in PS Civil Lines vide DD no. 51 Dated 05/12/22 which was marked to SI Tarun Kumar PS Civil Lines, for enquiry and report. The I.O. SI Tarun Kumar enquired into the matter which reveals as the I.O. requested the petitioner several time to join the enquiry but the petitioner never tuned up nor provided the screenshot/video to establish the real facts, to the enquiry officer SI Tarun Kumar of PS Civil Lines, Delhi. However, a closed borewell was found at 2 B, Goela Lane, Civil Lines, Delhi for which a letter was sent to the area SDM for site inspection on dated 19.05.23. Finally after the long wait I.O. submitted his enquiry report and recommended to file the complaint as the matter is of civil in nature in lack of evidences not provided by the petitioner and no offence was made out. The complaint was filed accordingly. The same is annexed herewith as annexure P.

Later, SDM lodged a complaint at PS Civil Lines on dated 17.05.24 against the occupier alleging that on dated 02.11.23, SDM had sealed the borewell working at 2 B, Goela Lane, Civil Lines, Delhi. However on dated 12.04.24 during inspection SDM found that seal has been tampered by owner/occupier. Therefore, SDM gave a complaint against the occupier/owner who tampered the seal. Regarding this a case FIR No. 374/24 u/s 188 IPC dated 01.08.24 has been registered and case is pending investigation. Copy of FIR has been attached as annexure R.

**Sub: Regarding sealing of borewells at 2B, Goela Lane, Under Hill Road, Civil Lines, Delhi-110054.**

Whereas in pursuance of Hon'ble National Green Tribunal, New Delhi order dated 06.10.2023, 01.11.2023 and 22.12.2023 in the matter of Nakul Kapoor Vs DPCC & Ors. in OA No. 297/2023 the property No. 2B, Goela Lane, Under Hill Road, Civil Lines, was inspected by the then SDM Ms. Meena Tyagi and 02 illegal borewells were found running which were sealed on 02.11.2023.

Whereas a joint inspection was again carried out by Sh. Sunny Dalal, ASO, O/o SDM Civil Lines and Sh. Pankaj Panday, JE, Delhi Jal Board at 2B, Goela Lane, Under Hill Road, Civil Lines, Delhi-110054 on 12.04.2024 and it was found that 01 borewell was dismantled by the owner/occupier and rest of 02 Nos of borewell were in working condition which were sealed on 12.04.2024.

A show cause notice dated 20.04.2024 to Sh. Nagender S/o Late Sh. Musafir Mahto (owner/occupier 2B, Goela Lane, Under Hill Road Civil Lines) Resident of H.NO. 6B/1, Under Hill Road, Civil Lines Delhi was issued with the direction to show cause why the borewells already sealed on 02.11.2023 has been tempered with seal and again put to the working condition. However, reply from Sh. Jitender Sharma R/o 34/24, Gali No-14, Bhajanpura has been received (copy enclosed) which is not found satisfactory.

Therefore, the borewells already sealed on 02.11.2023 has been tempered with seal and again put to the working condition. A legal action may be taken against the owner/occupier in the matter.

**Subject:-** Regarding complaint against the owner/builder of property bearing no. 2 B, Goela Lane, Under Hill Road, Civil Lines, Delhi 110054 against illegal draining the ground water for constructing the basement and damaging trees.

**Gist of the complaint:-** The complainant Sh. Nakul Kapoor presently residing at H.No. 5642, second floor, gali No. 2, New Chandrawal, Jawahar Nagar, Delhi 110007 alleged that the owner/builder of aforesaid property is constructing basement, illegally draining the ground water and flushing the same in the sewer line and also damaging the nearby trees.

**Enquiry conducted:-**

On the receipt of complaint, the enquiry got conducted and the complainant got contacted several times on his given mobile phone to establish the real facts of the complaint but the complainant never responded and adopted delay tactics with one pretext to others and never joined enquiry and never provided the screenshot of the video and images which he claimed to have despite of repeated requests. DD entry in this regard is enclosed herewith as **annexure A**.

After that, address given by the complainant was also visited by the undersigned but complainant was not found present there. Caretaker/owner of the property stated that Nakul was living on the above said address as tenant and lived there for 3-4 months and left from there in march 2023. He does not know new address of the Nakul. Self-written statement of caretaker/owner Mayank Nagar has been attached herewith as **annexure B**.

On local spot enquiry, it revealed that there has some construction for the past 5-6 months at property in question for which the beat staff of area has sent information letter to MCD authority vide no. 1900-1906/R-SHO/CL PS Civil Lines, Delhi dated 11/10/22 and the same is annexed herewith as **annexure C**. Further owner of above said property Sh. Lokesh Gupta joined the enquiry who stated that all the allegation are false and baseless. He is constructing his property as per MCD norms. Statement of alleged builder/owner Sh. Lokesh

Gupta was recorded which is annexed herewith as annexure D. As for draining water, a closed borewell was found there, for which a request letter has sent to the area SDM for site inspection and the response thereof is awaited till date. Received copy of the letter has been annexed herewith as annexure E. Moreover, no any damage to nearby trees was noticed.

**Conclusion :-** Keeping in the view of above said facts stated above, the allegation found not to be substantiated and matter is of civil in nature and no criminal offence is made out. As approve, the complaint may be filed please.

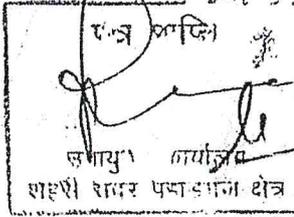

- A. The owner/builder of the aforementioned property is constructing the basement in the property and illegally draining the ground water and flushing the same in the sewer line of Delhi Jal Board.
- B. The owner/builder draining and flushing the ground water from more than 3 months.
- C. There are 3-4 trees adjacent to the basement and the construction of basement will damage/kill them.
- D. I also have a video which corroborates this complaint. Complainant had taken the screenshot from the video and file some images alongwith this complainant.

It is pertinent to mention herein that, in the basement, the water is coming out of from rocks. It is further pertinent to mention herein that civil lines area is situated adjacent to Kamla Nehru Ridge and there are 2-3 natural lakes in the ridge and one of the lake is *Khooni khani Jheel*. The water which is draining by the owner/builder is ground water or either the source of that water might be one of the lake situated at Kamla Nehru Ridge.

Therefore, I requested you all the Sir(s) to take immediate and strict action against the owner/builder of the property bearing no. **2B, Goela Lane, Under Hill Road, Civil Lines, Delhi-110054** and prompt action require to do measure to restore the ground water or source of the water.
