
1. I say that there was a delay in filing the appeal before the Hon'ble National Green Tribunal. The Interlocutory Application has been filed by the applicant to condone the said delay of 82 days under Section 14 of the Limitation Act, 1973 as the applicant was before Hon'ble High Court of Bombay by



way of Writ Petition. The Hon'ble Court has directed the Ld Tribunal to consider the application under section 14 of the Limitation Act.

2. I say that although the writ petition was disposed of on 30.04.2025 with liberty to approach the Hon'ble National Green Tribunal, I was in the presence of several legal experts on the issue regarding the maintainability of the appeal before the NGT as well as on the merits of the matter. Some considerable time was lost in doing the said exercise. After obtaining appropriate legal advice, I had entrusted the Advocate on Record to file the appeal on 30.06.2025. The Advocate on record after perusing the papers of the Appeal and after obtaining instructions instructed me to supply some additional documents so as to support the contentions to be raised in the appeal. Accordingly, I had consulted my Environmental Consultant to procure the requisite documents and handed over the same to my Advocate on Record. After obtaining the requisite documents, the Appeal was drafted by my Advocate on Record and was duly sworn in on 15.07.2025.

3. My Advocate on Record was trying to file the appeal from 15.07.2025, however, could not submit it online due to technical



glitches. My Advocate personally visited the Registry of this Hon'ble Tribunal whereas he was provided with the number of an authorised person from the Registry to get in touch with the query. My Advocate was in constant follow-ups with the authorised person and the members of the Registry. My Advocate was called upon to share the login details to the authorised person so as to verify the technical glitch. Accordingly, my advocate had shared the login credentials to the authorised person. Moreover, my Advocate was asked to share the screen through the g-meet link for understanding the glitch.

4. It was only after myriad efforts both at the end of my Advocate and the Registry of this Hon'ble Tribunal, the technical glitch was identified by the Registry of this Hon'ble Tribunal and ultimately resolved whereas the appeal was successfully submitted on 22.07.2025. Copies of the email communications exchanged by my Advocate and the Registry of this Hon'ble Court are annexed herewith and marked at **Exhibit "SA-1"** **collectively** whereas the screenshots of the whatsapp messages exchanged between my Advocate and authorised technical person and other members of the Registry of this Hon'ble




Tribunal, are annexed herewith and marked at Exhibit "SA-2" collectively.


