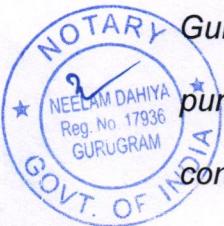

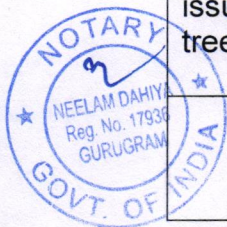

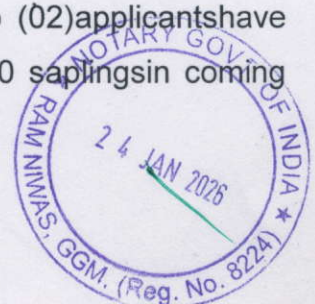

6. That it is submitted that in reply of notices issued, two (02) applicants have undertaken to carry out compensatory plantation of 3580 saplings in coming




rainy season or suitable plantation season. The copies of undertaking submitted by two notices are annexed as **Annexure – R/3**.
