

**STATUS REPORT ON BEHALF OF MUNICIPAL
CORPORATION FARIDABAD BY WAY OF AFFIDAVIT
OF DHIRENDRA KHADGATA, COMMISSIONER,
MUNICIPAL CORPORATION, FARIDABAD.**

MOST RESPECTFULLY SHOWETH:

1. That this Hon'ble Tribunal after considering report submitted by Joint Committee passed order dated 15.04.2025. The relevant portion of order dated 15.04.2025 is reproduced below:-

"35. The Commissioner, Municipal Corporation, Faridabad is directed to file compliance report in this regard by way of his own affidavit at least one day before the next date of hearing fixed.

36. The Commissioner, Municipal Corporation, Faridabad is also directed to give in his report all requisite details regarding steps taken for compliance with directions given vide order dated 05.07.2023 passed in M.A. No.69/2022 in Original Application No. 331/2022 and Execution Application No. 26/2022 in Original Application No.331/2022 titled Omprakash Vs. State of Haryana & Ors..

37. The District Magistrate and the Commissioner of Police, Faridabad are directed to provide requisite assistance including

providing of police help and arranging the help of armed forces, if so required, for removal of the encroachment and demolition of the structure.

38. In the eventuality of failure to do so, the Commissioner, Municipal Corporation, Faridabad, the District Magistrate, Faridabad and the Commissioner of Police, Faridabad shall appear before this Tribunal physically on the next date of hearing fixed to explain the reasons for noncompliance with the directions already issued and this order.

39. In view of orders passed by Hon'ble Supreme Court the District Magistrate, Faridabad is also directed to take appropriate steps for filing of contempt of court proceedings against concerned persons/concerned Office Bearers of the Residents Welfare Association for violation of the order passed by Hon'ble Supreme Court before Hon'ble High Court of Punjab and Haryana in case of any further non-compliance by them."



2. A show cause notice bearing no. MCF/JCF/2025/520. dated 13.03.2025 was served to the violator / encroacher and the same was pasted on the door of Mandir but the violator / encroacher failed to comply with the said show cause notice. Accordingly, demolition order was passed vide office document no. MCF/JCF/2025/662 dated 09.04.2025 which was given to Pandit / Pujari of the Mandir but he refused to give the signature on receipt.
3. That on 07.05.2025 the demolition squad alongwith Duty Magistrate reached at site for carrying out demolition of the unauthorized Temple / Mandir, but during the course of demolition drive heavy protest erupted by the local residents and meanwhile the prominent persons present on the site requested for time of one week for relocation of the idols placed/fixed inside in the temple.

4. That in view of the severity of situation, seven days time was granted for the task of respectful relocation of idols. After that, once again demolition drive was fixed for 15.05.2025 for carrying out demolition of the unauthorized structures but in the meanwhile the encroachers filed a CWP No. 13790 of 2025 titled as "Shree Radha Krishan Trust vs. State of Haryana" in the Punjab & Haryana High Court, Chandigarh. In the said CWP the Punjab & Haryana High Court stayed the demolition of property in dispute vide order dated 14.05.2025. Now the said matter is fixed on 22.07.2025. A copy of order dated 14.05.2025 passed by the Hon'ble High Court is annexed as **Annexure R-1.**

5. That in compliance with the order dated 05.07.2023 passed by this Tribunal in MA No. 69/2022 in Original Application No. 331 of 2022 & Execution Application No. 26/2022 in Original Application No. 331 of 2022 titled as "Om Prakash vs. State of Haryana & Ors," the detail of 770 parks being maintained by Municipal Corporation Faridabad has been filed vide affidavit dated 20.12.2023 **Annexure R-2.**

6. That in compliance with the order dated 15.04.2025 advertisement has been published in National Newspaper namely "Dainik Jagran" on 25.05.2025 for creating public awareness against construction of illegal religious structures on public land / public parks etc. **Annexure R-3.** Further, appropriate instructions for creating public awareness are also being published by way of publication of Advertisement in more National/Local Newspapers in both English & vernacular language apprising the members of public about directions given by Hon'ble Supreme Court prohibiting raising of religious structures on public land/public park etc., such religious structures being liable to the demolished and the violators being liable to appropriate penal action including initiating of contempt of Court proceedings against them for contempt of orders passed by Hon'ble Supreme Court.

7. That in compliance with the order dated 15.04.2025 all the Joint Commissioners, Municipal Corporation Faridabad were directed to prepare an Action Plan and ensure the removal of all illegal religious structures erected on public parks, green spaces, green belts, etc., within a period of one month.

Furthermore, as per the directions of the Hon'ble National Green Tribunal, the Deputy Commissioner, Faridabad, was requested to keep providing requisite assistance to Municipal Corporation Faridabad including police force and to take appropriate steps for filing of contempt of court proceedings against concerned persons/concerned Office Bearers of the Residents Welfare Association for violation of the order passed by Hon'ble Supreme Court before Hon'ble High Court of Punjab and Haryana in case of any further non-compliance by them.

Additionally, the Deputy Commissioner, Faridabad, was also requested to instruct the field staff of the various department under you that as and when any complaint / information regarding illegal construction of religious structures on public park / green belt / green spaces / public land etc. comes to their notice, the same may be conveyed to the Municipal Corporation Faridabad, to the Municipal Corporation Faridabad, so that timely and appropriate action may be taken against such unauthorized religious structures in a time bound manner.

8. Therefore, it is humbly submitted that the Municipal Corporation Faridabad is making every effort to ensure to comply with the directions passed by this Hon'ble Court.

The status report is being submitted for consideration of this Hon'ble Tribunal. The answering Corporation shall abide by further directions passed by this Hon'ble Court.

MOST RESPECTFULLY SHOWETH:

I, the above named deponent do hereby solemnly affirm and state as under:-

1 That the aforesaid captioned matter came up for hearing before the Hon'ble Tribunal, Principal Bench on 01.03.2023 when the following direction was issued:-

"In view of the facts and circumstances of the case, the Commissioner, Municipal Corporation, Faridabad is directed to file affidavit furnishing information in tabular form with details regarding revenue number, size/area, location of the parks, open lands, vested in the Municipality, meant for the public amenities to the residents of the locality to maintain ecology, sanitation, recreation, playground and ventilation purposes within six weeks by email at judicial-ngt@gov.in preferably in the form of searchable PDF/OCR supported PDF and not in the form of Image PDF".



- 2 That in compliance of order dated 01.03.2023, an affidavit dated 28.04.2023 was filed with details of the parks in tabular form in the locality i.e. within approximately 1000 meter.
3. That after considering the affidavit dated 28.04.2023, this Hon'ble Tribunal passed the order dated 05.07.2023, relevant portion of which is reproduced below:

"2. We have gone through the reply filed by the Commissioner, Municipal Corporation, Faridabad and we find that complete information regarding all parks/open lands vested in the Municipal Corporation, Faridabad has not been given in the reply. The Commissioner, Municipal Corporation, Faridabad is directed to file additional reply giving complete information regarding all parks/green belts/open lands within municipal limits of Faridabad City with all requisite details including revenue number, size/area, location, present status, encroachments if any and action taken for removal of such encroachments."



- 4 That as per information provided by the Horticulture Department of MCF there are 770 parks being maintained by the MCF. Requisite details of those 770 parks is annexed herewith as **ANNEXURE-R/1**.
5. That it is humbly requested that in respect of parks falling under jurisdiction of other agencies of State i.e. HSVP, Town & Country Planning Department etc., those agencies may be directed to submit relevant information directly before this Hon'ble Tribunal or same can be considered in OA No.68/2022 (Raman Sharma Vs SoH & Ors.) wherein this Hon'ble Tribunal vide order dated 28.03.2023 has constituted a Joint Committee of various authorities to compile information regarding all green areas/parks/green belts reserved in the respective areas of all the Municipal Bodies in the State of Haryana.
