(Kaushalya Sharma Vs Mathura Vrindavan Development Authority & Ors.)**

Sir,

During your visit to our society on 12.05.2024, we came to know about your appointment as Amicus. During your visit, we also informed you that we all residents are living in the society happily and peacefully. Only one lady i.e. applicant has spoiled the peaceful environment of the society due to her quarrelsome nature and various litigation before various Forums. The applicant is not residing there rather visit occasionally.

Present Case is nothing but a tool to create problems for us. We came to know the applicant is insisting upon to remove pakka base under re-developed green belt.

Sir, quality of water supplied and soil in Mathura-Vrindavan is not like as in Chandigarh where applicant resides. Here water is salty and soil cause 'Dampness (सीलन)' from bottom to First Floor. Photos are attached. Earlier also green belt was having kachcha base but in view of wall conditions, at request of residents, it was made pakka. Now, if Re-developed Green Belt along residential towers is made Kachcha, same will enhanced the 'Dampness (सीलन)'. It is not so that greenery can't be maintained with pakka base. Grass and plants already being developed. IT IS ALSO TO BE NOTED THAT OUR SOCIETY IS SURROUNDED WITH WELL DEVELOPED GREEN BELT AT ITS THREE SIDES AS YOU ALSO HAVE SEEN.

It is therefore requested that re-developed green belt along residential towers be remain with pakka base in the interest of residents who are permanently residing in the society.

No mentinance charges like comman area electricity, water, cleaning security etc many owners like Kaushalya sharma since 2020. Only rs 1670-per month per two bhk flat is asked for but she is not cooperative.
