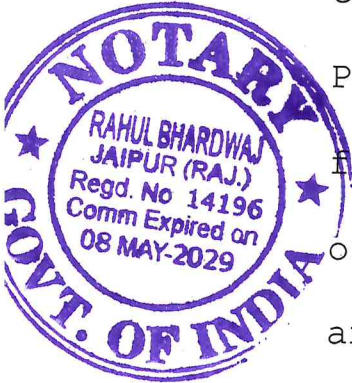

3. That a meeting of joint committee was conducted and it has been decided to survey of all the brick kilns running in the Bassi area. Thereafter, SDO, Bassi constituted a team comprising members from Revenue Department, Pollution Control Board and Mining Department for inspection/survey. A copy of the committee order dated 07.06.2024 is submitted herewith and marked as **Annexure-II**.

4. That the committee inspect the site and identified that 117 brick kilns are established in the area, out of them 27 brick kilns are closed and 90 brick kilns are in operative condition which were non-operative due to rainy season. Survey report submitted herewith and marked as **Annuxure-III**.

5. That the Mining Department submitted factual and action taken report dated 10.10.2024 and reported that out of 117 brick kilns, 27 brick

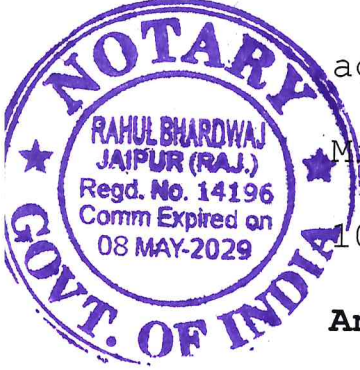

kilns are closed, 34 brick kilns having valid Short Term Permit (STP) and 56 brick kilns STP has either expired or not obtained and has also directed to take action as per rules against brick kilns violating The Rajasthan Minor Mineral Concession Rules, 2017. Letter 10.10.2024 submitted herewith and marked as

Annuxure-IV.

6. That out of 90 operative brick kilns, 5 brick kilns having land conversion for industrial purpose as per Revenue Rules and remaining 85 brick kilns are establish on agriculture land without proper land conversion.
7. That Regional Officer, Rajasthan State Pollution Control Board has submitted consent status of the brick kilns. The brick kilns are covered under orange category. The committee identified 117 brick kilns, out of them 27 brick kilns are closed and 90 brick kilns are in operative condition and having adequate stack height, Out of 90 brick kilns,
