The MSWD Balicha site was visited on dated 01/09/2023 at 11:30 am as per letter no. NGT/2023/780 dated 31/08/2023. The officials present at the site were as follows-


1. District Collector, Udaipur

**The committee has made following recommendations in their report-**

1. For the treatment of legacy waste at Balicha Site Legacy waste remediation plant shall be strengthened and expansion of the plant is required.
2. Fencing of the plant is required to prevent entering of animals such as cattle etc and the existing fencing may be repaired.
3. UIT & Municipal Corporation shall identify more location for the treatment of MSW around the Udaipur city to reduce long transportation and better regulation and to decrease the load at Balicha site.
4. Collection and segregation of roadside MSW shall be done by more scientific manner and more collection sites shall be provided.

5. The number of guards should be increased and a technical person shall be deputed to inspect the vehicle coming everyday and to ensure segregation and disposal of municipal solid waste and also to penalize those vehicles which are not covered or complied.
6. A nodal officer to be appointed to oversee the implementation of Solid Waste Management Rules, 2016 by Municipal Corporation.



**Visit report dated 01.09.2023 of MSW dumping yard situated at Balicha in compliance to Application No.38/2023(CZ), Anand Yadav & Ors Versus State of Rajasthan & Ors. Passed an order on dated 07/07/2023.**

The dumping yard situated at Balicha under Integrated Municipal Solid Waste Disposal Facility and Sanitary Landfill by Udaipur Municipal Corporation Limited at Arajji No. 2120/1970, 2121/1973, 2122/1996, village- Savina Kheda, Tehsil- Girwa, District- Udaipur, State of Rajasthan was to be inspected as per HON'BLE NGT in OA No. 38/2023(CZ) dated 07/07/2023.


A committee for inspection of The Integrated Municipal Solid Waste Disposal Facility and Sanitary Landfill Balicha (hereinafter referred to as 'MSWD Balicha') site was constituted by District Collector vide Order no NGT/2023/686 dated 27/07/2023. The MSWD Balicha site was visited on dated 01/09/2023 at 11:30 am as per letter no. NGT/2023/780 dated 31/08/2023. The officials present at the site were as follows-

1. District Collector, Udaipur
2. Municipal Commissioner, Udaipur
3. Sub Divisional Magistrate, Girwa, Udaipur

Status of NGT Order-

Hon'ble the National Green Tribunal Central Zonal Bench, Bhopal in Original Application No.38/2023(CZ), Anand Yadav & Ors Versus State of Rajasthan & Ors. Passed an order on dated 07/07/2023 as follows-

*“3. It is said that garbage dumped at the said yard is being burnt illegally and in utter violation of provisions of Rule 4(2) of Solid Waste Management Rules, 2016 (hereinafter referred to as 'SWM Rules, 2016') wherein burning of waste is prohibited. The waste includes chemicals and harmful materials which, after burning, release/emit harmful gases, causing damage to the habitat and also to environment in general. Repeatedly, applicant has made a complaint to the authorities concerned but no action has been taken in this regard. Even the cattles*




*and animals like cows are entering dumping yard eating garbage and polythene which ultimately results in death of animals and in this regard, no action has been taken”*

And constituted a Joint Committee comprising District Magistrate, Udaipur, Rajasthan State Pollution Control Board and Municipal Commissioner, Udaipur Municipal Corporation

The observation during the visit were as follows-

1. The Integrated Municipal Solid Waste Disposal Facility and Sanitary Landfill site Balicha lies at a distance of 9.2 Km from Udaipur city railway station and has following facilities-
  - i. Material Recovery Facility
  - ii. Bio Methanation Plant
  - iii. Legacy waste remediation plant
2. Presently approx 200 TPD of MSW is received at the site from Municipal and UIT area of Udaipur City, out of which segregated MSW received from Municipal area is 100 TPD & and rest is partially segregated from UIT area. However road side dumped waste received from municipal & UIT area is also unsegregated.
3. UIT Udaipur and Municipal Corporation have deployed tippers, trucks, etc. for collection and transportation of MSW to Balicha site. One Transfer Station at Ganesh Ghati, Kumharon Ka Bhatta Udaipur, is also provided by Municipal Corporation.
4. It was found during the visit that, the condition of collection of MSW was awful, unhygienic and complaint was found correct and animals & dead animals were found at the site.
5. So far as burning of garbage as concerned, no such activities was found due to rainy season, however the site persons working there inform that the burning of the waste automatically happens due to nature of the waste.
6. Approximately 5 to 7 lacs tons of Legacy waste was stored at the site in crude and unscientific manner. The legacy waste continuously being processed by 1000 TPD legacy waste remediation plant consisting of two Trow-mills of 500 TPD each. The RDF generated is sent to cement plant for co-incineration after drying up, other materials are being recycled and manure is used for plantation. As per the current legacy waste processing rate with no incoming of solid waste, the legacy waste can be stabilized



approximately within 2 year.


7. The bio-Methanation plant of 20 TPD is using wet waste and producing Biogas & manure. The biogas is produced at the rate of 7-8 gaskets of 25 Kg each and sold to M/s Secure Meters Pvt. Ltd and Toy Train at Gulab Bagh.

### **Recommendations-**

2. Fencing of the plant is required to prevent entering of animals such as cattle etc and the existing fencing may be repaired.

4. Collection and segregation of roadside MSW shall be done by more scientific manner and more collection sites shall be provided.
