3. The Hon'ble Chairperson, NGT is pleased to constitute the following Vacation Benches to hear matters which may require to be immediately or promptly dealt with.



 - (ii) Any case that may be filed at the National Green Tribunal Southern Zone Bench at Chennai or National Green Tribunal Central zone Bench at Bhopal or Western Zone Bench, Pune and National Green Tribunal Eastern Zone Bench, Kolkata, for urgent hearing, shall be promptly transferred for hearing to the Principal Bench of the National Green Tribunal.
5. The Registry and Office of the Principal Bench, National Green Tribunal and its Zonal Benches at Chennai, Bhopal, Pune and Kolkata will remain open daily from 10.00 AM to 5.00 PM except on Second Saturday, Sunday and other declared holidays, if any.
6. Limitation will not run during vacation period for the purposes of institution of appeals and applications under the provisions of the National Green Tribunal Act, 2010 and the Rules made thereunder.

7. All Appeals / Applications or other matters as may be required to be immediately or promptly dealt with can be filed with the Officer – On – Duty between 10.00 AM and 12.00 PM on all days except Second Saturday, Sunday and other declared holidays, if any.
8. It is further ordered that, National Green Tribunal Central Zone Bench, Bhopal, National Green Tribunal Sothern Zone Bench, Chennai & National Green Tribunal Eastern Zone Bench, Kolkata shall hold regular court sittings as per following schedule:


