2. **Place of Assignment.** He / She will work at the National Green Tribunal, Principal Bench, New Delhi.


3. **Remuneration.** Rs 30,000/- per month. May vary based on candidate's experience and utility.

4. The terms and conditions for the above engagement shall be as follows:-

- i. The person engaged shall perform his/her service as assigned by the Controlling Officer.
- ii. In special circumstance, the official can be called for service on holidays or duties can be assigned beyond normal working hours. The official is required to mark attendance.
- iii. The period of contractual engagement persons shall be decided by the Competent Authority, as per the requirement.
- iv. National Green Tribunal, Principal Bench shall have the right to examine/review the service rendered by him.
- v. He / She shall perform his/her obligation with all necessary skills, diligence, efficiency and economy.
- vi. During the term of service, he/she shall not engage in any private business or professional activity which could conflict with the interest of the Government.
- vii. He / She shall treat all the information as confidential and use the same only for the purpose of the performance of service.
- viii. The service can be terminated at any point of time, without giving any notice and assigning any reason thereof.


