


2. The terms and conditions for the above engagement shall be as follows :

 - ii. The working hours of the NGT from 9:30 AM to 5:00 PM with lunch break of 30 minutes from 1:30 PM to 2:00 PM with Saturday working (except 2nd Saturday).
 - iii. One casual leave shall be given in a month, to be availed with prior permission.
 - iv. In special circumstance, the duty of the consultant can be called for service on holidays or duties can be assigned beyond normal working hours. The consultants are required to mark attendance.
 - v. The period of contractual engagement persons shall be decided by the Competent Authority, as per the requirement.
