
In case any candidate wants to join the interaction through video conferencing, he has to indicate his preference before 30th April, 2023. If no such request/preference is received within such period, NGT shall have reason to believe that concerned candidate is supposed to appear personally for interactive session and in such eventuality, login credentials, i.e. link and password shall not be shared. It is further clarified that the candidate having failed to appear either physically or through Video Conferencing, shall be deemed to have absented voluntarily.

The login credentials, i.e. link and password will be provided on email id of candidate(s) having opted to appear through video conferencing, half-an-hour before the time of interaction. Candidate concerned may login with the credentials so provided, through Mobile Phone, Laptop or PC. After logging in, candidate has to wait in virtual waiting room for his turn and act as per instructions to be given.

IMPORTANT INSTRUCTIONS FOR CANDIDATES
