An EMD of Rs 40,000/- (forty thousand only) should be deposited on the spot from the successful bidder either in cash or in the form of DACR in favour of DDO NGT.

General Terms & Conditions :

1. Bidders may inspect the items on the stipulated date & time.
2. The items shall be sold to the highest bidder.
3. List of items are given in Annexure 'A'.
4. The Earnest Money Deposit (EMD) of successful bidder shall be adjusted from the total payment.
5. The successful bidder has to make full balance payment after adjusting the EMD, in the form of CASH/DCAR in "favour of DDO (NGT), within three days after confirmation, failing which the offer will be cancelled and the EMD shall stand forfeited. The EMD of unsuccessful bidders shall be returned within one month after the auction date without any interest.
6. No item once disposed to the successful bidder shall be taken back by this Department on any condition whatsoever.
7. The successful bidder will be required to lift all the items from the disposal site within three days after the payment of the balance amount. On failure to do so this Department shall have the right to forfeit the entire amount of the bidder and dispose the items to alternate bidder. The successful bidder, on their own cost, will also be required to make their own arrangement of transport, labour etc. for lifting the disposal items.

9. The financial bid should be quoted both in figures and words. Any overwriting or erasing in the figures shall not be considered for acceptance of the rates offered by the bidder.
