

- c) The bidder is required to pay earnest money of Rs.10,000/- with the sealed quotations. Earnest money is payable by means of Demand Draft/Pay Order drawn in favour of Registrar General, National Green Tribunal, Principal Bench, New Delhi-110001.
- d) Interested parties may submit their bid for the vehicle(s) stationed at Delhi and other Zonal Benches separately, as detailed above, in a sealed cover latest by **15-01-2023**. The inner cover containing quotation and other relevant documents along with DD/Pay Order towards Earnest Money Deposit (EMD) should be sealed properly.
- e) Bids/Quotations received without Demand draft/Pay Order towards Earnest Money will not be considered as valid and shall not be accepted.
- f) The successful bidder will be required to deposit the total bid amount by means of Demand Draft/Pay Order/Banker's Cheque in favour of Pay & Accounts Officer, Ministry of Environment, Forest & Climate Change, Indira Paryavaran Bhawan, New Delhi-110003.
- g) EMD of the successful bidder(s) will be released only after he/she deposits the sale proceeds. Earnest Money will be forfeited if he/she fails to honour the bid.
- h) The delivery of the sold vehicle(s) will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voters' Identity Card in case of individual and Registration Certificate in case of firms etc.).

- k) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his/her name at his/her own cost expeditiously. It will be the sole responsibility of the buyer for getting the necessary paper work done in accordance with the law and as per the provisions of the Motor Vehicles Act (amended from time to time) applicable for Transport Authority of Govt. of NCT of Delhi and the concerned States, Viz., Government of Tamil Nadu, Govt. of Madhya Pradesh, Govt. of Maharashtra and Government of West Bengal. This office will not be responsible for any lapse on the part of the buyer in this regard.
- l) NGT reserves the right to reject all or any bid in whole or part without assigning any reason thereof.
- (m) EMD of successful bidders shall be returned within three weeks of the award of contract to successful party.
